Vicky Mayfield, 36 Rocky Mountain Road, addressed the Council and stated the residents in the area were interested in getting City sewage on Rocky Mountain Road. She stated the Water Department had told her to speak to the City about getting the City sewage in that area.

Mayor Craft stated they were working on a bond issue at this time and that Rocky Mountain Road was one of the areas they were looking at for City sewage.
