The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford City Hall of the City of Oxford, Alabama, on Tuesday, February 14, 2023, at approximately 6:33 o'clock p.m. Council President Spurlin called the meeting to order.

APPROVAL OF MINUTES

Council Member Hubbard made a motion to approve the Consent Agenda, Resolution Numbers 2023-10 through 2023-14. The motion carried and the Consent Agenda, Resolution Numbers 2023-10 through 2023-14, were approved.

Council Member Henderson stated that there had been over 600 attendees at Parks and Recreation Senior Adult Valentine's Day Dance.

Mayor Craft stated that representatives of the Muscogee Nation would be touring the area over the next three days. He stated that at the last Vision One meeting with the students they had senior citizens also attend.

Council President Spurlin stated that Anna Jones, Girl Scout Troop 20136, had done a great presentation during the Work Session to earn her Gold Award and that she planned to attend the Naval Academy after high school graduation.

Council President Spurlin thanked Devon Bell, Associated MetalCast, Jason Goodgame, ADCON, and Don Hopper, Calhoun County Economic Development Council, for attending the meeting and the upcoming expansion for Associated MetalCast.

Council President Spurlin stated they needed to set public hearings for February 28, 2023, to consider the following requests which were approved by the Oxford Planning Commission at their January 19, 2023 meeting:

To amend the Zoning Ordinance, adding Article 13 to provide a set of use regulations and establish minimum standards for Short-Term Rental Dwellings within the City.
