Resolution No. 2023-104 – Resolution authorizing the Mayor to enter into a Letter of Agreement with the ASUN Conference to host the 2024 ASUN Softball Championships at Choccolocco Park.

Resolution No. 2023-105 – Resolution authorizing the Mayor to enter into a Change Order One agreement concerning the Oxford Recreation Complex (Choccolocco Park) Renovations and Additions for the Signature Softball Locker Rooms with Hale Building Company in the total amount \$29,034.00.

Council Member Henderson made a motion to approve the Consent Agenda, Resolution Number 2023-97 and Resolution Numbers 2023-102 through 2023-105. The motion was seconded by Council Member Gardner; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried and the Consent Agenda, Resolution Number 2023-97 and Resolution Numbers 2023-102 through 2023-105, were approved.


