SECTION ONE ADVERTISEMENT AND NOTICE FOR BIDS (2020)

The Bid Opening is scheduled for Thursday, June 4th, at 11:00 A.M. CDT. In order to reduce exposure of all parties during current Coronavirus (COVID-19) pandemic, ONLY electronic bids will be received by the City of Tuscaloosa, Alabama, a Municipal Corporation, designated as the office of the awarding authority for this purpose, prior to the bid opening via email at <u>cculliver@tuscaloosa.com</u>. Electronic bids must be submitted in <u>.pdf format</u> to the City of Tuscaloosa., via email at <u>cculliver@tuscaloosa.com</u> <u>BEFORE</u> June 4th at 11:00 A.M. CDT</u>. Please put "ELECTRONIC BID FOR CITY HALL EXTERIOR ABATEMENT PROJECT" in the subject line of your email with your bid attached to it. The .pdf file shall be submitted with the Contractor Name and General Contractors License Number.

MBE/DBE/WBE Forms 1 & 2 located in Exhibit A of the Bid Documents are required to be submitted via email to <u>cculliver@tuscaloosa.com</u> no later than May 28th, 2020, by Midnight CDT.

MBE/DBE/WBE Forms 3, 4 & 5 located in Exhibit A of the Bid Documents are required to be submitted with the Bid.

The electronic bids will be read aloud via web-based videoconferencing software Zoom Meeting. Interested bidders are further encouraged to download and install Zoom Meeting, the Basic version of which is available for free, at: https://zoom.us/download.

This electronic bid opening is open to any member of the public and instructions for log in will be given by <u>Calvin</u> <u>Culliver, Graduate Engineer</u> by telephone at (205)248-5382 or by email at <u>cculliver@tuscaloosa.com</u> Instructions for video conferencing of the bid opening will be emailed to all plan holders.

Award of the contract will be made within forty-five (45) calendar days from the date of the bid opening.

1. The Project:

A. The Project shall be known as <u>City Hall Exterior Abatement Project</u> and the general character of said public works project shall consist of the following:

This project involves the removal of lead based paint on a majority of exterior windows at Tuscaloosa City Hall. This will result in minimal disturbance of the interiors at City Hall.

B. The approximate quantities of said Project are as follows: See Bid Schedule

C. Special instructions are as follows: <u>Contractors must comply with laws, ordinances, rules, and</u> regulations of Federal, State, and local authorities regarding removing, handling, storing, transporting, and disposing of lead waste materials. Comply with the applicable requirements of the current issue of 29 CFR Submit matters regarding interpretation of standards to the Ellis Architects for resolution before starting work. Where risk assessment plan requirements and the referenced documents vary, the most stringent requirement shall apply. The following local, state, and federal laws, ordinances, criteria, rules and

regulations regarding removing, handling, storing, transporting, and disposing of lead-contaminated materials apply. These regulation include but not are limited to: (a.) 18 VAC 15-30; (b.) 40 CFR Part 745; and (c.) 24 CFR Part 35. Licensing and certification in the State of Alabama is required.

D. The City will furnish the following: N/A

E. Time of Construction: From the date stated in the Notice to Proceed, the Project time of construction is <u>210</u> consecutive calendar days.

2. Plans and Specifications:

Plans and specifications and all related Contract Documents are open for public inspection at the office of <u>IPS</u>, located at Tuscaloosa City Hall, 2201 University Blvd., Tuscaloosa, Alabama 35401, and plans, specifications and other elements of the contract documents may be obtained from that same office. The contact person for the project is <u>Calvin Culliver</u>. They can be reached at (205) 248-5382; cculliver@tuscaloosa.com.

- A. Plans, specifications and Contract Documents may be obtained at the above location upon the deposit of \$______, which amount does not exceed twice the cost of printing, reproduction, handling and distribution of each set of such documents. Deposits by prime Contractor bidders are refundable in full upon return of all documents in <u>reusable condition</u> within ten (10) days of bid opening. Additional sets of bid documents for prime Contractor bidders, subcontractors, vendors or dealers may be obtained upon payment of the same deposit. Such deposits will be refunded, less the cost of printing, reproduction, handling and distribution, if all the documents are returned in <u>reusable condition</u> within ten (10) days of bid opening.
- B. All eligible refunds of deposits for plans and specifications will be made by the City within twenty (20) days of bid opening.

3. Qualification of Bidders:

- A. All bidders must be responsible, meeting the criteria and requirements set forth in the Instructions to Bidders and bid proposal.
- B. Prequalification of Bidders IS _____; IS NOT X required. If prequalification of bidders is indicated to be required by the preceding sentence, then written prequalification information is available for review at the same office where plans, specifications and Contract Documents are available.
- C. The attention of all bidders is called to the provisions of State law governing "general Contractors," as set forth in Ala. Code §34-8-1, et seq. (1975), and rules and regulations promulgated pursuant thereto.
- D. If a construction manager is being utilized and this contract is one of a multiple of trade contracts, then the bidder shall be fully licensed for the trade, as determined by applicable law.
- E. The City may not enter into a contract with a non-resident corporation or entity which is not qualified under State law to do business in the State of Alabama.
- F. All bidders shall possess all other licenses and/or permits required by applicable law, rule or regulation for the performance of the work.
- G. All bidders must submit with their proposal, Contractor's license number and a copy of the license. State law, Ala. Code §34-8-8(b), requires all bids to be rejected which do not contain the General Contractor's current license number.
- H. The City reserves the right to reject all bids and/or reject and rebid the Project should it determine the same is in the best interest of the City.

4. Construction Manager:

If the preceding blank is marked with an affirmative indication, it means that this contract involves the use of a construction manager and this contract is one of several multiple trade and/or multiple prime contracts for work on the Project. Bidders attention is called to the supplemental conditions attached to the General Conditions of the Contract Documents regarding this topic.

5. Bid Bonds: Each bidder must submit with its bid a cashier's check drawn on an Alabama bank or a fully executed bid bond on the form that is contained in the Contract Documents executed by a surety company duly authorized and qualified to make bond in the State of Alabama. All bonds, sureties and/or cashier checks will be made payable to the City for an amount not less than 5 percent of the City's or its engineers or architects estimated cost of the Project or of the total bid in the proposal, but in no event more than \$10,000.00.

6. Sales and Use Tax Savings: Alabama Department of Revenue Rule 810-6-3.69.02(2010) exempts certain payment of state, county, and municipal sales and use taxes by the contractor or subcontractor on tangible personal property to be incorporated into the realty pursuant to a contract with a municipal corporation such as the City of Tuscaloosa. All tax exempt purchases shall be in accordance with the laws of this state and the Alabama Department of Revenue. It is the sole responsibility of the successful contractor to make the necessary inquiries and determinations as to what materials or items of tangible personal property to be incorporated into the project gualify as tax exempt in the opinion of the Alabama Department of Revenue. Unless otherwise noted, the project will be bid and administered in compliance with the State of Alabama Act 2013-205, Certificate of Exemption from Sales and Use Tax for Governmental Entities, regarding sales and use taxes. Sales and use taxes shall not be included in the bid. The Contractor shall be responsible for obtaining a certificate of exemption from the Alabama Department of Revenue for purchases of materials and other tangible property made part of the project. Any subcontractors purchasing materials or other tangible personal property as part of the project shall also be responsible for obtaining a certificate of exemption. The estimate sales and use tax saving must be accounted for on the bid proposal. Failure to provide the estimated sales and use tax savings may render the bid as non-responsive. Other than determining responsiveness of the bid, sales and use tax accounting shall not affect the bid pricing nor shall be considered in the determination of the lowest responsible and responsive bidder.

7. Pre-Bid Conference: A Pre-Bid Conference IS _____ IS NOT X required for this Project. If a conference is required, see attachment for specific instructions.

NOTE: All bidders are advised to carefully read the Instructions to Bidders contained in the Contract Documents, which provisions and requirements are adopted herein by reference.
