Sealed bids will be received by the City of Tuscaloosa Purchasing Department and must be received not later than **June 26, 2018, 2:00 PM**. Bids may be mailed to the City of Tuscaloosa, Purchasing Department, P.O. Box 2089, Tuscaloosa, Alabama 35403. Bids may be delivered to the City of Tuscaloosa Purchasing Department, 2201 University Boulevard, Tuscaloosa, Alabama 35401. **Bids received after the date and time specified will not be considered. Bidders must identify on the outside envelope the project name.**

Award of the contract will be made within forty-five (45) calendar days from the date of the receipt of bids.

**1. The Project:**

A. The Project shall be known as 2018 Road Striping Project (A18-0738) and the general character of said public works project shall consist of the following:

Perform thermoplastic road striping at locations as directed by the City's representative for the Project in quantities to be determined during a term of 365 days for a 60 day project. Bids will be made for unit pricing as follows, Striping with Class 2, Type A, Thermoplastic:

Traffic Control Markings- White, price per Square Foot: \$ \_\_\_\_\_/SF

4" solid Yellow stripe price per mile: \$ \_\_\_\_\_/mile

4" Broken Yellow stripe price per mile: \$ \_\_\_\_\_/mile

C. Special instructions are as follows:

Bidder's Response Form must be completed and submitted as Bid proposal/response and may be obtained at <http://www.tuscaloosa.com/bids>. Contractor shall supply and stripe 60mil yellow and white thermoplastic striping on streets as directed by the City's representative for the Project. Contractor will be responsible for all traffic control. Stripe and traffic control shall conform to the MUTCD.

D. The City will furnish the following: n/a

E. Time of Construction: From the date stated in the Notice to Proceed, the Project time of construction is 60 consecutive calendar days.

F. Term of Contract: The term of contract is 365 consecutive calendar days, subject to automatic extension for up to 2 successive periods of 365 days each. The term of the contract will not be automatically extended if, at the then-current expiration of the term, Contractor is in material breach of the contract.

**2. Qualification of Bidders:**

- A. All bidders must be responsible, meeting the criteria and requirements set forth in the Instructions to Bidders and bid proposal.
- B. The City may not enter into a contract with a non-resident corporation or entity which is not qualified under State law to do business in the State of Alabama.
- C. All bidders shall possess all other licenses and/or permits required by applicable law, rule or regulation for the performance of the work.
- D. All bidders must submit with their proposal any applicable license number and a copy of the license.
- E. The City reserves the right to reject all bids and/or reject and rebid the Project should it determine the same is in the best interest of the City.

Bidders attention is called to the supplemental conditions attached to the General Conditions of the Contract Documents regarding this topic.
