ADVERTISEMENT AND NOTICE FOR BIDS  
( 2019 )**

Sealed bids will be received by the City of Tuscaloosa, Alabama, a Municipal Corporation, in the Council Chamber in the City Hall, 2201 University Boulevard, on the 10th day of December, 2019, until 9:00, a.m. local time, and then publicly opened and read for the furnishing of all labor and material (where required) and equipment for performing a public works project according to the plans, details, specifications and Contract Documents.

Award of the contract will be made within ten (10) calendar days from the date of the bid opening.

**1. The Project:**

A. The Project shall be known as **TUSCALOOSA CITY WALK PROJECT 10<sup>TH</sup> AVENUE SECTION AND THE EDGE/CW DATA CENTER HUB (City Project Nos. A19-1050/2019.028.001** and the general character of said public works project shall consist of the following:

Installation, termination, testing, labeling, and documentation of a complete fiber/cabling infrastructure system and termination hardware on the 10<sup>TH</sup> Avenue Section of the CityWalk and the Edge/CW Data Center Hub as well as the Existing TDOT Fiber Relocation along 10<sup>TH</sup> Avenue.

B. The approximate quantities of said Project are as follows: Installation of (3) 288 count, (1) 120 count, (2) 24 count, and (22) 6 count fiber optics cabling as designed in the specifications and the required termination hardware. Installation of multiple runs of CAT6 OSP station cabling in the poles for wireless access points and cameras. As well as the relocation of existing (1) 288 count TDOT fiber optic cable.

C. Special instructions are as follows: **Forms 1 and 2 for the City's MBE/DBE/WBE Program are MANDATORY and are due by, and no later than, 5:00 pm CST on Tuesday, December 3, 2019** to Caramyl Drake, Community Development Program Manager, Infrastructure and Public Services/Tuscaloosa Builds, City of Tuscaloosa, Phone: (205) 248-5725, [cdrake@tuscaloosa.com](mailto:cdrake@tuscaloosa.com). These forms and the complete MBE/DBE/WBE Policy can be found in your Bid Package.

**Forms 3, 4 and 5 for the City's MBE/DBE/WBE Program are to be included and enclosed inside your sealed bid.**

**The Contract/ Bid includes the Data Network Equipment to be installed (Labor Only). The City/Owner shall be providing all Data Network Equipment.**

**Tax must be INCLUDED in the Contractor's base bid, see Section 6 below for more details.**

D. The City will furnish the following: The approximate quantities of said Project for the Data Network Equipment are as follows: Installation of (4) Fiber NTWK. Switches with (106) Fiber GBIC Modules, (1) 10/100/1000 Copper-NTWK. Switch, and (22) Industrial Grade NTWK. Switches with (44) Fiber GBIC

Modules, (22) Industrial Grade NTWK. Power Supplies and (2) UPS/ Battery Units as designed in the documents.

E. Time of Construction: From the date stated in the Notice to Proceed, the Project time of construction is Ninety (90) consecutive calendar days.

## **2. Plans and Specifications:**

Plans and specifications and all related Contract Documents are open for public inspection at the office of TTL, Inc., located at Tuscaloosa, Alabama, and plans, specifications and other elements of the contract documents may be obtained from the office of the Engineer/Architect TTL, Inc., designated as the office of the awarding authority for this purpose, located at 2890 Rice Mine Road NE, Tuscaloosa, Alabama, 35406. - A. Plans, specifications and Contract Documents may be obtained at the above location upon the deposit of \$ 100.00 , which amount does not exceed twice the cost of printing, reproduction, handling and distribution of each set of such documents. Deposits by prime Contractor bidders are refundable in full upon return of all documents in reusable condition within ten (10) days of bid opening. Additional sets of bid documents for prime Contractor bidders, subcontractors, vendors or dealers may be obtained upon payment of the same deposit. Such deposits will be refunded, less the cost of printing, reproduction, handling and distribution, if all the documents are returned in reusable condition within ten (10) days of bid opening.
- B. All eligible refunds of deposits for plans and specifications will be made by the City within twenty (20) days of bid opening.

## **3. Qualification of Bidders:**

- A. All bidders must be responsible, meeting the criteria and requirements set forth in the Instructions to Bidders and bid proposal.
- B. Prequalification of Bidders IS \_\_\_\_\_ ; IS NOT  X  required.  
If prequalification of bidders is indicated to be required by the preceding sentence, then written prequalification information is available for review at the same office where plans, specifications and Contract Documents are available.
- C. The attention of all bidders is called to the provisions of State law governing "general Contractors," as set forth in Ala. Code §34-8-1, et seq. (1975), and rules and regulations promulgated pursuant thereto.
- D. If a construction manager is being utilized and this contract is one of a multiple of trade contracts, then the bidder shall be fully licensed for the trade, as determined by applicable law.
- E. The City may not enter into a contract with a non-resident corporation or entity which is not qualified under State law to do business in the State of Alabama.
- F. All bidders shall possess all other licenses and/or permits required by applicable law, rule or regulation for the performance of the work.
- G. All bidders must submit with their proposal, Contractor's license number and a copy of the license. State law, Ala. Code §34-8-8(b), requires all bids to be rejected which do not contain the General Contractor's current license number.
- H. The City reserves the right to reject all bids and/or reject and rebid the Project should it determine the same is in the best interest of the City.

**4. Construction Manager:**

N/A If the preceding blank is marked with an affirmative indication, it means that this contract involves the use of a construction manager and this contract is one of several multiple trade and/or multiple prime contracts for work on the Project. Bidders attention is called to the supplemental conditions attached to the General Conditions of the Contract Documents regarding this topic.

**5. Bid Bonds:** Each bidder must submit with its bid a cashier's check drawn on an Alabama bank or a fully executed bid bond on the form that is contained in the Contract Documents executed by a surety company duly authorized and qualified to make bond in the State of Alabama. All bonds, sureties and/or cashier checks will be made payable to the City for an amount not less than 5 percent of the City's or its engineers or architects estimated cost of the Project or of the total bid in the proposal, but in no event more than \$10,000.00.

**6. Sales and Use Tax Savings:** Contractors are to include tax in their base bid. Sales and use taxes SHALL be included in the bid. Exemption from Sales and Use Tax for Governmental Entities WILL NOT be applied for due to the time constraints of this project. A certificate of exemption from the Alabama Department of Revenue for purchases of materials and other tangible property WILL NOT be issued nor applied for. In addition, the estimate sales and use tax saving must be accounted for on the bid proposal in the appropriate section of the Bid Proposal Form. Failure to provide the estimated sales and use tax savings in the appropriate section of the Bid Proposal Form may render the bid as non-responsive. Tax must ALSO be INCLUDED in the Contractor's base bid.

**7. Pre-Bid Conference:** A Pre-Bid Conference IS NOT X required for this Project. If a conference is required, see attachment for specific instructions.

**NOTE:** All bidders are advised to carefully read the Instructions to Bidders contained in the Contract Documents, which provisions and requirements are adopted herein by reference.
