RESOLUTION AUTHORIZING EXPENDITURE OF \$350,000 TO THE
ALABAMA DEPARTMENT OF TRANSPORTATION FOR US-82 AT
UNIVERSITY BOULEVARD PROJECT

WHEREAS, the Tuscaloosa County Road Improvement Commission (TCRIC) has entered into a funding agreement with the State of Alabama Department of Transportation (ALDOT) that allows for certain reimbursements by and between these parties; and

WHEREAS, ALDOT has requested \$350,000 for this priority project for intersection improvements to the University Boulevard interchange at US-82, (see request attached hereto as Exhibit A); and

WHEREAS, the project is identified as "Project 4-D" in the TCRIC-ALDOT agreement; and

WHEREAS, the TCRIC has expended \$0 of the \$350,000 currently authorized by the TCRIC budget in FY 2022 for the above-described project.

NOW, THEREFORE, BE IT RESOLVED, by the Tuscaloosa County Road Improvement Commission, that \$350,000 be paid to the Alabama Department of Transportation to fund costs for improvements at US-82 at University Blvd.
