SUITE STAFF

Crimson Tide Hospitality FANGINEERS™ will staff the Suite Level. FANGINEERS™ are responsible for maintaining exclusive access to the suite level as well as assisting guests with game-day requests. FANGINEERS™ can adjust the retractable windows at the discretion of the suite holder.

Seasons Culinary Group will be on-call to assist with food and beverage needs. It is their responsibility to ensure that your food and beverage orders are delivered.

Tipping of the suite staff is not expected.

SUITE WINDOWS

Your suite windows can be opened by a FANGINEER™.

CABINETS

Each suite is equipped with non-locking cabinets. The cabinets are for your convenience and are not intended for secure storage of valuable items.

BUD'S BEST PLAYGROUND

The playground courtesy of Bud's Best Cookies will be open for use this season.

PROCEDURES

SUITE HOLDER RESPONSIBILITIES

The suite holder is requested to identify the responsible administrator for the suite. The administrator will serve as the primary contact for all food and beverage orders and communication. All communication regarding food & beverage, and satisfaction surveys will occur between the administrator and the CTH Manager.

COMMUNICATION

You may direct all questions and requests regarding your suite to Hailey Meyer with Crimson Tide Hospitality.

Gameday suite e-newsletters will be emailed to the email on file with TIDE PRIDE. E-newsletters will provide club menus, times for gate opening and first pitch, and any other pertinent information.

Notifications regarding rain delays, postponements and cancellations will be communicated through text messaging.

MOBILE TICKETING

You, the suite holder, will receive your tickets via email, allowing you to transfer tickets to your guests. Tickets should be saved in your Apple Wallet (iPhone) or Google Pay Wallet (Android). Just prior to reaching gate 14, fans will simply open their digital wallet, select their game tickets, and hold their smartphone near the scanner. TIDE PRIDE handles all suite tickets, license agreements, and billing. Please call (205) 348-2262 for assistance regarding these issues.

Should you need ticket assistance on non-gamedays, please contact the Ticket Office at (205) 348-2262. If a ticket holder needs ticket assistance on gameday, please visit the Sewell-Thomas Ticket Office window.

Suite holders will also have access to the suites for post-season play in Sewell-Thomas Stadium. Tickets for post-season play must be purchased separately from regular season tickets.

HOURS OF OPERATION

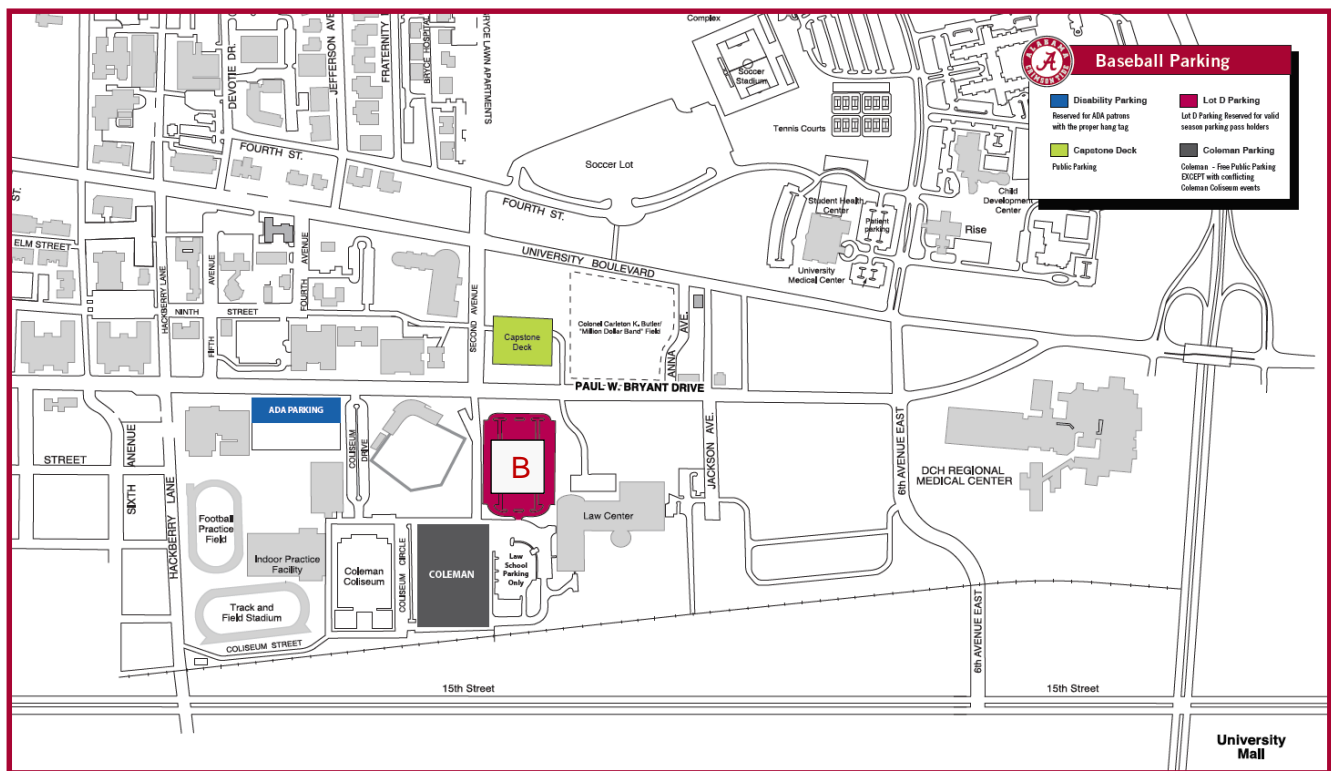
This season Sewell-Thomas Suites and club areas will open 2 hours prior to the first pitch and will close 30 minutes following the completion of the game.

In the .525 Club, snacks, fountain drinks, tea and coffee will be available from gate opening until the end of the game. The main buffet will be served starting 1 hour prior to the first pitch through the 4th inning. The bar will be open from gate opening until the start of the 7th inning.

If you need to access your suite to deliver personal items such as blankets or sunscreen, please contact Hailey Meyer with Crimson Tide Hospitality.

PARKING

All Suite guests will park in Lot B. Please see the parking map below for reference.



STADIUM ENTRY

Everyone, regardless of age, is required to present a ticket to gain admission into Sewell-Thomas Stadium.

Suite ticket holders are **required to use Gate 14 to enter the stadium** and receive their designated wristband.

Crimson Tide Hospitality personnel will scan tickets at the gates.

SUITE ADMISSION

Admission to the suites requires a Sewell-Thomas Stadium Suite game ticket.

Once a suite ticket holder enters Gate 14, a FANGINEER™ will scan your ticket and affix a wristband to the individual. This wristband will allow the individual to travel in & out of the suite level to .525 Club. Wristbands must be worn at all times. Please do not remove your wristband, as a replacement will not be provided. Any patron without a suite wristband will be asked to leave.

Suite guests are not authorized to enter the Press Box.

CLEAR BAG POLICY

Fans will be able to carry the following style and size of bag, package or container into the coliseum:

- Bags that are clear plastic, vinyl or PVC & do not exceed 12" x 6" x 12" with or without one logo imprint no larger than 4.5" x 3.4"
- Clear, One (1) gallon plastic storage bags (Ziploc bags or similar)
- Small clutch/wallet, no larger than 4 ½" by 6 ½" with or without a handle or strap

RE-ENTRY POLICY

Patrons who leave the stadium will not be allowed re-entry without an unused ticket.

- Cameras with telephoto lenses larger than 6"
- Chair Backs larger than 16"
- Computers & Laptops [iPads & Tablets are permitted]
- Coolers
- Flags/Banners on poles
- Strollers
- Umbrellas
- Video recorders/camcorders
- Weapons

CLEANING & MAINTENANCE

Restroom facilities will be regularly cleaned and disinfected with electrostatic sprayers prior to each game. During the game, restroom attendants will also regularly clean and disinfect flush valves and sink handles. Custodial & Facilities Services will be available during operating hours. Members should contact a FANGINEER™ or any staff member for custodial or maintenance needs.

SMOKE-FREE CAMPUS

The University of Alabama prohibits smoking inside all facilities, grounds, and parking areas on campus. This includes Sewell-Thomas Stadium.

INCLEMENT WEATHER PLANS

The University of Alabama has a detailed weather safety plan in place that is reviewed every season. In the event of severe weather, guests will be instructed to move to safe areas by staff, public address announcements and instructions on the videoboard. Alabama Athletics consider our guests' safety first priority.

FIRST AID

Located in the outer concourse behind home plate (section KK). For a medical emergency or first aid assistance, notify the nearest staff member.

FOOD & BEVERAGE

We want you and your guests to be absolutely delighted with your experience at Sewell-Thomas Stadium, and we will strive to make every detail as smooth and easy for you as possible.

BUFFET

Suite guests will enjoy the all-inclusive food and non-alcoholic beverage experience in the .525 Club. In addition to the game selection, guests can enjoy a hot dog, chips & salsa, or other gameday fare. Load up on peanuts, popcorn, cookies and more. Fountain beverages and freshly brewed Red Diamond tea & coffee will be provided.

Fountain drinks and snacks will be available from gate opening until the end of the game. The main food offerings will be available 1 hour prior to first pitch and will be replenished through the 4th inning. A full bar will be available from gate opening until the start of the 7th inning.

IN-SUITE FOOD & BEVERAGE

Outside food and beverages are strictly prohibited. It is not permissible for suite holders or guests to bring outside food and/or beverage into the suite. Seasons Culinary Group is the exclusive caterer for the suites and clubs in Sewell-Thomas Stadium.

For in-suite catering, review the food & beverage options on the following pages, and visit www.crimsontidehospitality.com to place your order. The Crimson Tide Hospitality staff will provide you with your login information.

Beverage orders will be accompanied by suitable cups and beverage napkins. Food orders will be accompanied by appropriate plates, dinner napkins and utensils.

Due to Food Health and Safety Regulations, all food must be disposed of at the end of each game. No food is to be stored in the suite beverage coolers.

FOOD & BEVERAGE TIMING

ORDERING: To ensure order fulfillment, in-suite food & beverage orders should be placed by 12:00 noon, two (2) business days prior to each game (12:00 noon Friday for any Monday or Tuesday games). If you miss the advance order deadline, don't despair! We also offer a smaller "Gameday" menu of freshly prepared food items.

CANCELING: Please notify us as soon as possible of any cancellations. You will not be charged for orders cancelled by noon, one (1) business day prior to the game, or by Friday at noon for a Monday game. Cancellations must be confirmed by Crimson Tide Hospitality to be valid. Any cancellations after the deadline will assess a penalty fee up to 100% of the total order value

including all applicable taxes. In the event of a game cancellation, penalty fees will not be assessed unless the gates were opened prior to the event being cancelled.

IN-SUITE DELIVERY: We strive to deliver your order to your suite with premium freshness; therefore, items may be delivered after you or your guests arrive to ensure freshness. F&B: THE FINE PRINT

PAYMENT INFORMATION

A credit card is required for all in-suite orders. When placing your order, we will request all pertinent credit card information to securely keep on file for the duration of the baseball season.

Credit cards will be charged each Monday for orders placed and delivered the previous week. E-receipts will be sent to the primary contact.

All items ordered on gameday will be charge to the credit card on file unless specifically requested.

PERSONAL DISHES

Staff is not responsible for washing any personal dishes brought in by the suite holder unless it is specifically requested.

SERVICE OF ALCOHOL

It is strictly prohibited, by law, to bring alcoholic beverages into (or remove them from) the suites from outside the stadium. To maintain compliance with rules and regulations set forth by the local laws, we ask that you adhere to the following:

It is the responsibility of the Suite Holder or their representative to monitor and control alcohol consumption in the suite.

Minors, by law, are not permitted to consume alcoholic beverages. It is unlawful to serve alcoholic beverages to anyone who appears to be intoxicated. No passing alcoholic beverages from one suite to another, to club patrons or to patrons in the general seating.

Seasons Culinary Group holds the alcohol license for Sewell-Thomas Stadium suites & club levels. SCG reserves the right to check for underage drinking at any time. Suite holders are responsible for ensuring that no one in their suite under the age of 21 is consuming alcoholic beverages.

A SERVICE FEE OF 10% WILL BE ADDED TO YOUR IN-SUITE ALCOHOL ORDER.

Tuscaloosa City Laws prohibit the sale of alcoholic beverages before 10:00 AM on Sundays. Sewell-Thomas Suites and club will adhere to this policy for all Sunday games. Alcohol ordered for suites will not be unlocked from cabinets/coolers until 10:00 AM on Sundays.

RULES & REGULATIONS

1. Suite holders' rights of use in the Suites are subject to terms stated in the License Agreement and the following Rules & Regulations, which may be supplemented and amended without prior notice to Suite holders.
2. The Sewell-Thomas Suites will be used only during University of Alabama home baseball games and specified events approved by The University of Alabama Athletic Department.
3. The Sewell-Thomas Suites may not be used for overnight accommodations.
4. The Suites may not be used for any unlawful purpose.
5. Suite holders agree to maintain the Suite in good condition, and to reimburse The University of Alabama Athletic Department for any damage done to the Suite by the owner or guests other than ordinary wear & tear.
6. Suite holders may not make alterations, additions, or improvements without obtaining permission from The University of Alabama Athletic Department. Written requests may be submitted to the Hospitality Director for approval.
7. Ticket Purchaser shall maintain the assigned Suite seating area and its furnishings and equipment in good condition, ordinary wear and tear excepted, and shall promptly reimburse the University for the cost of repairing any damage in excess of ordinary wear and tear caused by the Ticket Purchaser or Ticket Purchaser's guests or caused by the construction or the removal of unapproved alterations, renovations, decorative additions, or other improvements to the Suite seating area. The University shall have the right to remove and dispose of any unapproved changes or improvements in any manner it deems appropriate.

8. Except as expressly authorized by any rules and guidelines governing the Suite seating area or as otherwise expressly approved in writing by the University, Ticket Purchaser shall make no alterations, renovations, decorative additions, or other improvements to the Suite seating area. Should any such changes or additions be approved by the University, Ticket Purchaser, prior to termination or within five (5) days after the date of cancellation of this License Agreement, shall remove all such alterations, renovations, decorative additions, or other improvements or changes and at its expense restore the Suite seating area to substantially the same condition that existed at the commencement of the term of this License Agreement. Any approved alterations, renovations, decorative additions, or other improvements which are not so removed with such five (5) day period shall become the property of the University and may be disposed of in any manner the University deems appropriate.
9. All Suite holders are requested to respect the rights of other Suite holders and ensure that all activities conducted in the Suite area are done so in a thoughtful and courteous manner.
10. Smoking is prohibited at all times and at all locations on The University of Alabama campus, including indoor and outdoor athletics venues and facilities.
For the purposes of this policy, "smoking" means inhaling, exhaling, burning, carrying, or possessing any lighted product, including cigarettes, cigars, pipe tobacco, and any other lit products, and the use of electronic cigarettes or similar devices.
11. Artificial noisemakers are not permitted in the Suites.
12. Video recording equipment and video recording is prohibited in Sewell-Thomas Stadium.
13. Banners or items similar in nature may not be displayed outside the Suite windows.
14. Food or beverage may not be taken from the Suite areas into the public areas.
15. All alcoholic beverages must be placed in opaque cups.
16. No food or beverage is to be brought into the stadium. In-suite food orders can be coordinated with the Crimson Tide Hospitality office and should be placed 2 business days prior to home games. Charges incurred for special orders are to be paid by the Suite holder.
17. Suite holders are discouraged from using the cabinets for storing valuables, as there may be significant variations in temperature and humidity, which may result in damage to personal items.
18. Storage of flammable materials is forbidden.
19. A Sewell-Thomas Suite game ticket is required for all individuals, including children of any age.
20. Minors attending the game are to remain in the Suites, unless attended by an adult to other areas, and then chaperoned at all times while outside of the Suite. It is necessary that Suite holders and guests refrain from offering suite staff and security personnel food or beverages before, during or after games.
21. The University of Alabama will not distribute door keys to Suite holders since the Suites are only leased for University of Alabama home baseball games.
22. The above Rules & Regulations are subject to alterations based on requirements and policies established by The University of Alabama, the SEC and the NCAA.
23. Suite holders agree to comply with the above rules and guidelines and to be responsible for its guests' compliance with such rules and guidelines. If the Suite holder or guests violate any rule or guideline, the University, in its sole discretion, may require the Suite holder and/or guest(s) to leave Sewell-Thomas Stadium immediately.

24. In no event shall the Suite holder at any time permit more persons to occupy the Suite than the number allowed by the posted occupancy limit established by the Fire Marshall. Fire codes require that this limitation be strictly enforced.
25. Ticket Purchaser agrees that the University shall not be liable for personal injury or loss or damage to personal property of Ticket Purchaser or of Ticket Purchaser's guests occurring in Sewell-Thomas Stadium, including the Suite seating area. Ticket Purchaser shall indemnify and hold harmless the University from and against any liability whatsoever for personal injury or property damage occurring in Sewell-Thomas Stadium, including the Suite seating area.
