The City will be submitting to the U. S. Department of Housing & Urban Development a One-Year Action Plan for Program Year 2022, the third (3<sup>rd</sup>) year of its Five-Year Consolidated Plan for the Community Planning and Development Programs for Program Years 2020-2024.

On **Thursday, April 14, 2022**, The City of Tuscaloosa will hold a public hearing to solicit and receive public comment from citizens, agencies, and other interested parties for proposed housing and community development projects and programs to be undertaken by the City with 2022 Community Planning and Development (CPD) Program funds. These CPD Programs include the Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME) and the Emergency Solutions Program (ESG).

Citizens can provide suggestions, recommendations, ideas, and comments on proposed projects and programs for the City of Tuscaloosa to implement for its Program Year 2022 Annual Action Plan.

Also at this time, the City of Tuscaloosa will receive pre-applications from citizens, agencies and other interested parties for housing and community development projects and programs to be undertaken by the City with 2022 Community Development Block Grant (CDBG) and HOME funds.

The public hearing will be held on **Thursday, April 14, 2022** at 5:00 P.M. in the City Council Chambers at Tuscaloosa City Hall, located at 2201 University Boulevard Tuscaloosa, AL 35401.
