The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford City Hall of the City of Oxford, Alabama, on Tuesday, March 8, 2022, at approximately 6:38 o'clock p.m. Council President Spurlin called the meeting to order.

Mayor Craft stated that they were proud of the Oxford High School Girls Basketball Team and he appreciated the fan support from the city.

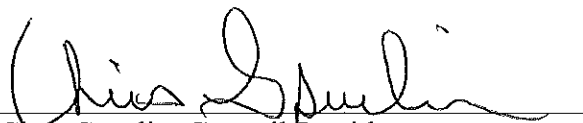

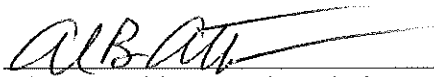
Ron Allen, City Attorney, stated he did certify that the Council was adjourning into Executive Session to discuss a possible economic development.
