**WHEREAS**, the City has determined said property is not needed for a municipal purpose.


**NOW THEREFORE BE IT ORDAINED BY THE CITY OF OXFORD,  
ALABAMA AS FOLLOWS:**


**Section 1.** The real property owned by the City referenced above is hereby declared surplus to the needs of the City of Oxford and is therefore no longer needed for a public purpose.

**Section 2.** This ordinance shall become effective upon its passage by the Council and publication as required by law.




