ORDINANCE NUMBER 2022-37

An Ordinance to Amend the Zoning Laws of the City of Oxford, Alabama, a

Municipal Corporation

BE IT ORDAINED by the City Council of the City of Oxford, Alabama, as follows:

Section 1. The following described real estate lying and being in the City of Oxford,

Alabama, shall be zoned Agricultural District (AG).

Property located in the NE ¼ of the NE ¼ of Section 11 and the NW ¼ of the NW ¼ of

Section 12 Township 17 South, Range 7 East, Talladega County, Alabama. Being divided from a

larger parcel and being described as:

Commencing at an existing iron pin found (pipe) on the northerly ROW of Denney Road

being the SE corner of Lot 5, of Windwood Estates S/D recorded in plat book 6, pg. 217; thence

N46°38'55"E a distance of 1653.61 feet to an iron pin set and the point of beginning of the

hereafter described property; thence N25°15'38"W a distance of 92.73 ft. to an iron pin set; thence

N23°11'48"W a distance of 276.74 ft. to an iron pin set; thence S85°12'22"E a distance of 868.38

ft. to an iron pin set on the northwesterly ROW of Kirby Road (60 ft. ROW assessed); thence along

said ROW bearing S33°41'00"W a distance of 325.25 ft. to an iron pin set; thence leaving the

ROW bearing N86°54'20"W a distance of 420.53 ft. to an iron pin set; thence S81°20'53"W a

distance of 117.81 ft. to an iron pin set and the point of beginning, containing 4.81 acres, more or

less.

advertising as required by law.
