Dear Friends,

Collaboration, community involvement, preparation and planning are appropriate words to describe PARA's service to the community for the year 2012.



Significant collaborations throughout the year include: working with both branches of the YMCA on youth soccer and baseball programs, working with Tuscaloosa Tourism & Sports Commission to bring sporting events to our parks, working with the Kiwanis Club of Greater Tuscaloosa to build playgrounds, working with the Alberta community to build a gathering place, working with the West Alabama Mountain Biking Association to build miles of hiking and biking trails, working with the City to master plan Rosedale and Jaycee Parks, working with the County for park improvements in Holt and working with Boy Scouts to complete the boardwalk in front of Tuscaloosa Library.

One of the benefits of the collaborations made in the aftermath of the 2011 tornado was the relationships made with volunteer organizations. PARA is partnering with multiple volunteer organizations to stretch the taxpayer dollars. Thousands of hours of donated labor have gone into many of the projects completed in 2012.

PARA hired a park and recreation consulting firm to help us build a master plan for the future. The plan will show us where we stand when measured against other communities of similar size. The consultant's findings will provide us with the information needed for PARA and our elected leaders to determine where our organizational vision is for the future. In addition, PARA is working with the University of Alabama's MBA program to find ways to become more entrepreneurial.

Significant construction throughout the year includes the building of Faucett Brothers Activity Center and infrastructure improvements to numerous parks made possible by funding from the Tuscaloosa City Council.

PARA Mission

To enrich our community through exciting recreational and cultural opportunities



The Tuscaloosa County Park & Recreation Authority is constantly recreating itself to fit the needs and wants of the community. PARA offers parks, leisure activities and cultural arts. These diverse activities attract families and individuals of all ages and socio-economic levels. Because of PARA's broad audience, we have established a valued presence in Tuscaloosa County.

Established through a legislative act in 1969, PARA is a county-wide, non-profit agency funded by the City of Tuscaloosa, Tuscaloosa County and City of Northport and donations to the PARA Foundation. It is guided by an eight-member board of directors who are appointed by three local governments and two school boards.

PARA maintains 36 parks and boat landings, including six Activity Centers and approximately 2,200 acres of land spread throughout Tuscaloosa County. PARA properties include walking trails, a multipurpose arena, boat landings, ball fields, garden plots, playgrounds, indoor and outdoor swimming facilities, pavilions, Veterans Memorial Park, M-Bend Area of Hurricane Creek, the best municipal golf course in the state and Tuscaloosa's only First Tee chapter. PARA's Activity Centers offer the community indoor walking tracks, gymnasiums, workout facilities, meeting rooms and therapeutic pools. All amenities are open to the public and are either free or available for use with a fee. The variety of programs offered, coupled with subsidized rates make PARA a popular and essential part of the community.

In order to keep participation and user costs economical, PARA relies on funding from the three governmental entities we serve. This funding fluctuates annually and we continue to work toward increased funding from each of these sources as the community grows.

In addition to generating about 24 percent of our overall operating budget through program fees and charges and being fiscally frugal, PARA is often faced with difficult decisions.

Until a permanent funding source is secured PARA will always be faced with year-to-year financial uncertaintly and a backlog of deferred maintenance projects which makes planning for the future challenging.



PARA FOUNDATION

The objectives and purposes of the PARA Foundation shall be to promote, assist, advance and strengthen efforts to improve the availability and quality of parks and recreational facilities and opportunities in Tuscaloosa County and specifically to aid and assist the Tuscaloosa County Park & Recreation Authority, the governing bodies of Tuscaloosa

County, and the cities located therein, and other agencies of state and local governments, in connection with the development, improvement, and maintenance of parks and recreational facilities, programs, and opportunities. The Foundation shall conduct its affairs as a cultural, educational and benevolent, not-for-profit corporation, expressly limited to religious, charitable, scientific, literary or educational purposes within the continental limits of the United States of America.

The arts, our park lands and a variety of recreational opportunities are necessary for all citizens of Tuscaloosa County to ensure a good quality of life. Contributions are tax-deductible to the amount allowed by law and can be made in memory or in honor of someone or designated for a specific program or project. The PARA Foundation balance was \$136,852.50 as of September 30, 2011.

Veterans Memorial Park ENDOWMENT

The purpose of the Veterans Memorial Park Endowment is to raise funds with the principle being maintained in perpetuity and the annual earnings being allocated to enhance and maintain the park.

Located on McFarland Boulevard on the grounds of the former U.S. Army Northington General Hospital Chapel, the one-acre site has been retained in public ownership, with PARA's oversight. This historic site is mandated to have a beneficial public purpose.

The Veterans Monuments Park Association worked with representatives of local governments, PARA and the private sector to create this educational veterans park. To date, the majority of the costs have been donated by the private sector, including more than \$100,000 of in-kind construction activity.

The Veterans Memorial Park Endowment is overseen by the Board of Directors of the PARA Foundation. Donors may make gifts to the PARA Foundation, designating it for the Veterans Endowment, at any time.



PARA CENTERS

PARA has six multi-purpose centers conveniently located throughout the community. Each center has a gymnasium, exercise room, catering kitchen and rooms available to rent for meetings, parties, classes and other functions. Distinct center amenities include features such as indoor walking tracks, indoor therapeutic and or recreational pools.

Annual center memberships are available for purchase and allow use of common areas of all centers. Membership options, casual user fees and rentals are all reasonably priced. Since beginning the service in August 1997 through September 2012, there have been 53,914 center memberships purchased.

Jerry Belk Activity Center

- Opened August 1997; dedicated October 4, 1997
- Featuring tutoring for elementary school students, walking challenges, QuickStart Tennis and open volleyball

Faucett Brothers Activity Center

- Construction began January 2011; expected opening is Spring 2013

- Acquired December 1997; new addition dedicated June 13, 1999
- Featuring the Summer Food Program, offering 24,951 free lunches to children during the summer school break and "Kids in Kin" family parenting program

Leroy McAbee, Sr. Activity Center

- Opened April 1, 1998; dedicated July 4, 1998
- Featuring adult exercise programs and indoor pool

Bobby Miller Activity Center

- Opened September 1, 2006; dedicated September 10, 2006
- Featuring the Brown Branch of the Tuscaloosa Public Library, walking track and therapeutic pools

Mary Ann Phelps Activity Center

- Opened February 1, 1998; dedicated June 18, 1998
- Featuring Parent Track and Stroll Patrol walking programs, summer reading class and Quick Start Tennis















PARA's Recreation Division encompasses almost every activity imaginable including traditional sports, leisure classes, aquatics, therapeutic recreation, outdoor adventures, special events, youth, adult and senior activities. Highlights from these areas include:

- Sports activities for adults and youth including basketball, softball, volleyball, youth football, cheerleading and instructional soccer. New programs include disc golf and Dizzy Dean baseball.
- Leisure classes are available to the community for a variety of interests including but not limited to: Zumba, baton, dance & color guard, line dancing, Yoga, Pilates, watercolor painting and dog obedience.
- Activities for senior citizens remain very popular. Such activities include: leisure classes, line dance classes and special events such as cooking demonstrations, Breakfast & Bingo and The West Alabama Dance.
- The following aquatic programs are offered through PARA: swim lessons, water aerobics, Arthritis Foundation Aquatics, a pre-competitive swim program, lap swim, open swim times and much more. The pools are also available for private and group rentals and are often used for splash parties and other youth programs.
- The Therapeutic Recreation program is available to adults with developmental disabilities and/or physical challenges. The program provides activities that help promote socialization, physical coordination, activities of daily living and communication skills. Participation in Special Olympics, social clubs, travel opportunities and special events are among the offerings.
- Group and private tennis lessons as well as clinics, mini-camps and challenge ladders, held at the Jack Evans Tennis Complex in Bowers Park for people of all ages and abilities. Pick-up games and open court playtime is also available. The courts are lighted with play available during regular park hours, 6 a.m. -10 p.m. Continued...

- The Outdoor Adventure program provides opportunities for families, adults and active seniors to get outdoors and enjoy nature. The most popular trips are hiking and canoeing.
- The PARAkids Day Camp program hosted 503 elementary school-aged children during summer break and school holidays. The program offers structured recreation, skills and values that are key to child development. Activities include skating, swimming, bowling, arts and crafts, organized sports, field trips, special events, guest speakers and more.
- The Extended Day program at Rock Quarry Elementary School continues to be successful. Recreation, arts and crafts and tutoring are available to 145 students per day who participate during the school year.
- Youth sports such as girls and boys basketball, soccer, flag and tackle football and slow and fast pitch softball offer our youth additional opportunities to stay fit and develop athletically.
- "Celebration on the River," the annual Independence Day Celebration on July 4, 2012, was co-hosted for the second time with the City of Tuscaloosa. The riverfront amphitheater location proved to be a tremendous success and estimated attendance was over 20,000. The event featured a live concert by the Tuscaloosa Symphony Orchestra, a PARA's Kids Zone, the traditionally free children's activities and a fireworks finale at dusk.
- The 2012 PARA West Alabama Christmas Parade featured the theme "12 Days of Christmas." Grand Marshals Lee Allen Hallman and WWII Honor Flight Veterans led the annual parade, considered the largest in West Alabama. The parade was televised for the first time on local station WVUA-TV.

Tuscaloosa Arts Council



The Mission of The Arts Council is to promote and encourage the arts and humanities in Tuscaloosa County. The Arts Council serves as the umbrella organization for 50 Member Organizations, offers educational programs and manages the historic Bama Theatre. Member Organizations are local nonprofit arts and cultural groups that contribute to the local arts community through their programming and educational services.

The Bama Theatre is a historic theatre located in downtown Tuscaloosa surrounded by restaurants and nightlife. The theatre has

been a Tuscaloosa feature since 1938 and continues as a venue for entertainment and art. The Council also publishes a semi-annual arts magazine, Jubilation, which features artists and arts events in and around West Alabama. Art, educational, independent and foreign films are shown as part of the Bama Art House Movie Series. Film festival partnerships include the Jewish Film Festival, the Black Maria Film Festival, Manhattan Short Film Festival and the German Film Festival. The Arts & Humanities Council recognizes volunteers, educators and artists in the bi-annual Druid Arts Awards, and the Small Grants Program nurtures small and pilot arts activities. Bama Fanfare, SPECTRA, Poetry Out Loud and the Artists-in-Residence educational programs serve over 30,000 children annually. Annual exhibitions in the Junior League Gallery and the Greensboro Room gallery include the West Alabama Juried Show, the Visual Arts Achievement Awards and the Double Exposure Photography Competition. The Arts & Humanities Council will soon be opening the new Dinah Washington Cultural Arts Center. It is located in the existing four-story 1903 Allen/Jemison building situated at the corner of Greensboro Avenue and 7th Street in the heart of the downtown historic district on the same block as the Bama Theatre. The Dinah Washington Cultural Arts Center (CAC) will be a hub for the arts in Tuscaloosa. The CAC will have a black box theatre/workshop space which will house family programming, educational opportunities and rehearsal space or community meeting space for rent. In addition, the CAC will house offices for local arts groups and a gallery space for The University of Alabama.

Of Colony, Golf

The dream of a championship public golf course for Tuscaloosa was realized with the opening of Ol' Colony Golf Complex in the year 2000. Within one year, it was named one of the "Top 5 Best New Public Courses in America" by *Golf Digest*. Since then the Jerry Pate designed course has continued to live up to this reputation.



The name Ol' Colony is a reference to the Boys Colony, a former home and farm for boys with disabilities. The 597-acre site is leased from the Alabama Department of Mental Health. Remaining acreage is ample enough for an additional 18 holes. Initial project funding came from a \$3 million loan from the City of Tuscaloosa, a \$3 million bond issue backed by the Tuscaloosa County Commission and private donations.

The First Tee of Tuscaloosa is dedicated to providing young people of all backgrounds the opportunity to develop life skills through golf and character education is the youth component of Ol' Colony. Now in the thirteenth year, it has grown to serve participants on site and in the community. With the implementation of The First Tee National School Program into Tuscaloosa City and County elementary schools, the Tuscaloosa Chapter impacted over 15,000 youths and has 425 certified youth.

The Jerry Pate Golf Center at Ol' Colony is one of the top practice facilities in the nation and serves as the official home of the University of Alabama's men's and women's golf teams. The 2012 team boasted the women's SEC golf championship while the men's team placed second.

The Pro Shop is fully stocked with everything a golfer might want in brand name golf gear. The Diner features an expanded menu of breakfast and lunch offerings made to order. Alfresco dining on the patio makes for a memorable Ol' Colony experience.

The Brion Hardin First Tee Teaching Facility is equipped with a Trackman Launch Monitor, V1 Pro Software and Explanar Plane System, an indoor putting area and two hitting bays for fittings and lessons. Individual and corporate rates/lesson packages are available.

District DEVELOPMENT

In 2012, the Tuscaloosa County Commission allocated \$200,000 to Tuscaloosa County Park & Recreation Authority to be used in four districts for development. Each district received \$50,000 to be spent during the fiscal year.

Since 1995, the District Development program has contributed \$2,543,464.09 to community projects and the community has contributed \$5,062,634.73 in matching funds.

The Advisory Committee represents all four districts within the count with a cross-section of citizens serving on the committees to review project requests. The committee makes recommendations to the PARA Board of Directors and final approval is made by the Tuscaloosa County Commission.

District Development Projects Completed in 2012

District 1: Northside Little League purchased bleachers, constructed an asphalt walking track and completed a field extension to comply with the new Dixie Youth regulations. Tuscaloosa County High School football boosters installed a sprinkler system in practice fields and installed a French drain under the track. Huntington Place Elementary School purchased and installed four outdoor basketball goals.

District 2: North East Tuscaloosa Sports completed upgrades to their park in Abernant. This included parking, improvements to the concession building, batting cages and restrooms. The Town of Coaling installed an accessible sidewalk to connect the parking lot to the ball field complex. The Vance Community Park placed fencing in their new sports complex. The Brookwood Park Association completed the construction of a multi-purpose field.

District 3: The Taylorville Community Club moved the electrical lines and added sewer lines for the new concession building. In addition, they installed a catch basin and drainage. Duncanville Middle School installed a backstop and fence for their softball field.

District 4: Myrtlewood Elementary School purchased new play equipment for their playground. Sipsey Valley High School purchased poles and lighting for their athletic complex.

Capital Projects

The West Alabama Mountain Biking Club constructed hiking/biking trails at Lake Lurleen State Park and Sokol Park using equipment that was purchased with a grant from the national Recreational Trails Program.

Another RTP grant provided for the construction of a bridge to connect a walking trail in Queen City Park along Jack Warner Parkway.

PARA was the recipient of a \$100,000 grant from Tully's Coffee through the Pomegranate Center. A "Gathering Space" was built in Jaycee Park during a one-week community-wide project build.






