The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford City Hall of the City of Oxford, Alabama, on Tuesday, February 28, 2023, at approximately 6:37 o'clock p.m. Council President Pro Tempore Waits called the meeting to order.

Ron Allen, City Attorney, was present.

Alan Atkinson, City Clerk, was present.

Lem Burrell, Lakeview Baptist Church, prayed the Invocation.

Council President Pro Tempore Waits led the Pledge of Allegiance to the Flag.

APPROVAL OF MINUTES

Council President Pro Tempore Waits stated each member of the Council had previously received a copy of the minutes of the February 14, 2023, meeting. Council Member Henderson made a motion that the minutes be approved as presented. The motion was seconded by Council Member Gardner.

Council President Pro Tempore Waits called for any comments or questions; there being none, on roll call the votes of the Council were as follows: ayes: Council Members Hubbard, Gardner, Waits and Henderson; nays: none; absent: Council President Spurlin. The motion carried.

NEW BUSINESS

Council President Pro Tempore Waits announced that was the time for the public hearing to consider an ordinance amending the City of Oxford Zoning Ordinance 2017-20 providing regulations to allow Short-Term Rentals within the City, declared the hearing open and asked if anyone wished to address the Council either in favor of or in opposition to said proposed

Ordinance No. 2023 – 03 – Ordinance amending the City's Zoning Ordinance 2017-20 adding Article 13 to provide a set of use regulations and establish minimum standards for Short-Term Rental Dwellings within the City

Council Member Hubbard made a motion for the unanimous consent of the Council for the immediate consideration of Ordinance Number 2023-03. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, and Henderson; nays: none; absent: Council President Spurlin. The motion carried.

Unanimous consent of the Council having been given for the immediate consideration of Ordinance Number 2023-03, Council Member Hubbard made a motion to approve Ordinance

Number 2023-03. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, and Henderson; nays: none; absent: Council President Spurlin. The motion carried and Ordinance Number 2023-03 was approved.

Council Member Henderson stated he had spoke to Ms. Haynes about the short term rentals. He stated there were a lot of regulations in this ordinance to prevent any negative issues and if negative issues did arise the ordinance could be amended or repealed. He stated the Inspections Department and the Fire Department would be involved in the approval of any short term rentals. He stated that they were taking into consideration the concerns of the citizens with respect to the short term rentals.

Council Member Hubbard stated this ordinance was written so short term rentals could not just open without any regulation. She stated there was a permitting process before anyone could open a short term rental.

Council President Pro Tempore Waits stated the next item on the agenda was the Consent Agenda.

Council Member Gardner made a motion to approve the Consent Agenda, Resolution Numbers 2023-15 through 2023-22. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, and Henderson; nays: none; absent: Council President Spurlin. The motion carried and the Consent Agenda, Resolution Numbers 2023-15 through 2023-22, were approved.

Council Member Hubbard stated they had all received a request from Mr. Bunn concerning recycling for funding to modify the trailer that had been purchased with grant funds. She stated this trailer was to be placed in the Bynum area. She stated the funding request was around \$4,000.00. She stated that they could discuss this funding at their next work session.

Council Member Henderson stated that representatives of the Muscogee Nation had recently been in Oxford and the surrounding area touring various sites. He stated the Fitness Court was now in place at Choccolocco Park.

Council President Pro Tempore Waits stated they needed to set public hearings for March 14, 2023, to consider the following requests which were approved by the Oxford Planning Commission at their February 7, 2023 meeting:

Zoning request from Martha Stokes to rezone property located at 763 Beck Road from Residential District (R-1) to Agricultural District (AG)

There being no further business to come before the Council, Council Member Henderson made a motion to adjourn. Council President Pro Tempore Waits declared the meeting adjourned at approximately 6:53 o'clock p.m.
