

## **ADVERTISEMENT FOR BIDS**

Sealed proposals will be received by the Purchasing Department at City of Talladega AL until **10:00 a.m. on September 25, 2023**, at 255 South Street West, Talladega, AL, for the construction of

### **City-Wide Select Street Rehabilitation, Phase 2**

at which time and place they will be publicly opened and read.

A summary of the work items is included below:

Rehabilitation of several city streets within the city limits of Talladega, AL consisting of approximately 6,200 tons of bituminous concrete paving, approximately 3,000 gallons of tack coat, approximately 5 miles of temporary and permanent, reflective traffic striping, and approximately 2,000 square feet of thermoplastic traffic control markings, and 400 tons of full depth pavement patching.

Performance and Payment Bonds and evidence of insurance required in the bid documents will be required at the signing of the Contract.
