### **ORDINANCE NO. 1935**

AN ORDINANCE TO ESTABLISH PARKING RESTRICTIONS UPON A PORTION OF PULLIAM STREET LOCATED ON THE SOUTH SIDE OF THE SOUTHERN RAILROAD TRACK; TO PROVIDE FOR THE ERECTION OF APPROPRIATE SIGNS IN SAID STREET AREA; AND TO PROVIDE PUNISHMENT FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TALLADEGA, ALABAMA, AS FOLLOWS:

## **SECTION 1.**

<u>**Definitions**</u>: As used in this Ordinance, the following terms shall have the following meanings unless the context clearly indicates a different meaning:

- (a) "Vehicle" shall mean every device which is self-propelled, or device in, upon or by which any person or property is or maybe transported upon a street;
- (b) "Parking" shall mean the stopping or standing of a vehicle, whether attended or unattended, upon a street or roadway;
- (c) "Operator" shall mean every individual who shall operate a vehicle, as the owner thereof or as the agent, employee, licensee or permittee of the owner, or who is in actual, physical control of a vehicle; and

## **SECTION 2.**

<u>Parking Prohibited</u>: It shall be unlawful for the operator of any vehicle to place, park or leave standing any vehicle or automobile upon or along either side of that street known as Pulliam Street located on the south side of the Southern Railroad Track from the intersection of the West right-of-way line of Martin Luther King, Jr., Drive westerly to the ending point of Pulliam Street.

#### SECTION 3.

The Chief of Police, or a designee, shall erect and place appropriate "No Parking" or such similar signs as the Chief of Police may select for use and shall cause the curb within such areas of prohibited parking, if there be curbs, to be painted yellow within such no parking zones hereinabove described to indicate that parking is prohibited in such areas.

# **SECTION 4.**

Any person who shall be convicted of violating any provision of this ordinance shall, upon conviction, be punished by a fine of not less than One Dollar (\$1.00), nor more than Five Hundred Dollars (\$500.00), or by imprisonment in the City Jail for not less than one hundred eighty (180) days, or both, at the discretion of the court trying the case.

## **SECTION 5.**

All sections of this ordinance are hereby declared to be severable; and if any word, phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional or invalid by the judgment or decree of any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining words, phrases, clauses, sentences, paragraphs and sections of this ordinance.

## **SECTION 6.**

Any existing ordinances in conflict herewith are hereby repealed.

## **SECTION 7.**

This ordinance shall take effect immediately upon its passage and publication, as provided by law.
