



**Lincoln Chrome Sweepstakes
Official Rules**

1. Eligibility

Lincoln Chrome Sweepstakes (the "Sweepstakes") is open only to individuals who are legal residents of and physically located in one (1) of the fifty (50) United States or the District of Columbia and who are eighteen (18) years of age or older, at the time of entry. To participate and enter this Sweepstakes, during the Sweepstakes Entry Period: (i) visit a retailer that carries Lincoln Chrome products; (ii) purchase at least one (1) Lincoln Chrome exhaust kit consisting of qualified two (2) elbows, two (2) tops stacks, two (2) spools, two (2) or four (4) clamps, brackets/clamps plus an item from a list of qualified Sweepstakes approved SKUs (list of qualified products can be found below); (iii) go to www.lincolinchromesweepstakes.com; (iv) Register to the Sweepstakes with your First Name, Last Name, Email Address, name of the Retailer, and the name of your Lincoln Chrome Salesperson; (v) Upload an image of your receipt as a proof of purchase of Lincoln Chrome exhaust kit. You will receive one (1) entry into the Sweepstakes for each valid receipt showing a proof of purchase of the qualifying Lincoln Chrome products. To enter without making a purchase, send a 3.5" x 5" postcard with following information hand-printed in blue ink, your full name, mailing address, email address, and telephone number, to Lincoln Chrome Sweepstakes c/o Contest Factory, 17602 17th Street #102 – 116, Tustin, CA 92780. Post card must be postmarked by April 15, 2019 and received no later than April 22, 2019. Your postcard must be hand-printed clearly and legibly (illegible postcards will be disqualified). Each mailed in entry must be received individually. You will receive one (1) entry for your first postcard which



is received and one (1) entry for each subsequent postcard received. **Limit of three (3) total entries per person for the Sweepstakes regardless of the method of entry.** Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Use of any automated system to participate is prohibited and will result in disqualification and all associated entries will be void. Sponsor reserves the right to substitute the listed prize for one of comparable or greater value for any reason. ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

11. Governing Law/Disputes

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of California, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws. The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in Orange County, California and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in Orange County, California. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Orange County, California. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.

12. Entrant's Personal Information
