2020-2024 COMMUNITY PLANNING AND DEVELOPMENT PROGRAMS CONSOLIDATED PLAN

The City of Tuscaloosa (City) will be submitting to the U. S. Department of Housing & Urban Development a One-Year Annual Action Plan for Program Year 2024 (PY24), the fifth (5th) year of its Five-Year Consolidated Plan for the Community Planning and Development Programs for Program Years 2020-2024.

In development of this PY24 Annual Action Plan, the City will hold **four (4) public hearings** to solicit and receive public comment from citizens, agencies, and other interested parties for proposed housing and community development projects and programs to be undertaken by the City with 2024 Community Planning and Development (CPD) Program funds. These CPD Programs include the Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME).

During the public hearings, City staff will be available to take residents' written and/or verbal comments, suggestions, recommendations, and/or ideas on proposed projects and programs for the City of Tuscaloosa to implement for its Program Year 2024 Annual Action Plan.

The four (4) public hearings will be held on the following dates and times:

The public hearings will be held at Tuscaloosa City Hall in the City Council Chambers, located at 2201 University Boulevard Tuscaloosa, AL 35401.
