Council President Pro Tempore thanked Calhoun County Commissioners Danny Shears and Terry Howell for their support of their youth. He thanked the students from Oxford and Alexandria for their involvement in the meeting.

Council Member Hubbard stated that Vision One could grow to promote regionalism and they were looking forward to that.

Council President Spurlin stated that it had been mentioned tonight that a lot goes on at Choccolocco Park other than sports. He stated they have a rodeo coming up at the end of this month and a fishing rodeo coming up in June for the youth of the area.

Mayor Craft welcomed and thanked the students and parents from the Alexandia community for being at the meeting and stated he appreciated them being involved in their community.

Council President Spurlin stated they needed to set a public hearing for March 26, 2024, to consider a condemnation at 65 Moore Street

There being no further business to come before the Council, Council Member Hubbard made a motion to adjourn. Council President Spurlin declared the meeting adjourned at approximately 7:13 o'clock p.m.
