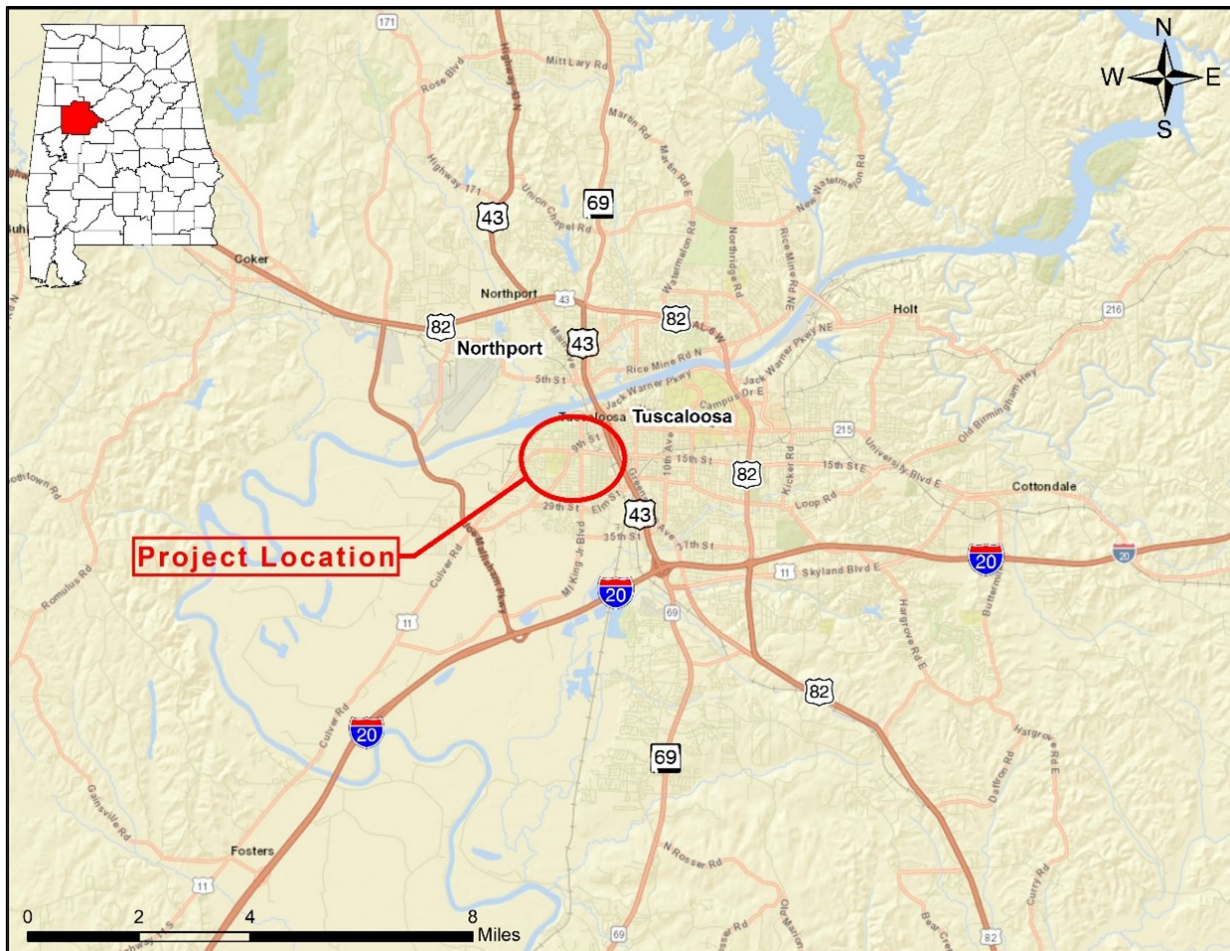
Stillman Boulevard Bridge Replacement

Purpose and Need:

The purpose of the proposed project is to replace an existing deteriorated bridge. The project is needed to address structural and functional deficiencies including inadequate pedestrian accommodations along Stillman Boulevard from Martin Luther King Jr. Boulevard to Nick's Kids Avenue.

Project Description:

The proposed project includes removing the existing bridge structure built in 1938 on Stillman Boulevard over the Canadian Pacific Kansas City (CPKC) Railroad (operated by WATCO Alabama Southern Railroad (ABS)) and replacing it with a new bridge designed to current structural and geometric standards. In addition, pedestrian and bicycle access will be improved by adding a 10-foot-wide multi-use path on the north side of Stillman Boulevard and a five-foot-wide sidewalk on the south side of Stillman Boulevard from Martin Luther King Jr. Avenue to Nick's Kids Avenue. Additional right-of-way will be needed to construct the proposed project.
