## TUSCALOOSA POLICE DEPARTMENT Internship and/or Ridealong Regulations

Thank you for expressing interest in participating in an internship and/or ride-along with the Tuscaloosa Police Department. We appreciate your enthusiasm for gaining insights into our daily operations and fostering community engagement. Please take a moment to familiarize yourself with the following guidelines. Your cooperation ensures a safe and educational experience for everyone involved.

#### Participant Age and Identification

Participants must be at least 18 years old.

Valid photo identification is required for verification purposes.

Participants must agree to a criminal background check and sign a non-disclosure agreement.

#### **Dress Code**

Participants are expected to adhere to a business casual dress code during their internship and/or during the ride-along. Blue
jeans are permitted, but please refrain from wearing dresses, skirts, shorts, open-toed shoes, tank tops or crop tops.

#### **Confidentiality Agreement**

 Strict confidentiality must be maintained. Participants are prohibited from disclosing any information witnessed during the ridealong, including sensitive operational details.

#### Compliance with Instructions

Participants must follow all instructions given by law enforcement personnel promptly and without hesitation. Be aware that the
officer accompanying you has the authority to conclude the ride-along if they deem it necessary.

#### **Restricted Areas and Equipment**

 Participants are to remain inside designated areas and vehicles, unless otherwise instructed by accompanying officers. Please refrain from touching Mobile Data Unit in the patrol vehicle.

#### No Independent Law Enforcement Activities

Participants are prohibited from engaging in any law enforcement activities or taking independent actions during ride-along.

#### No Use of Cell Phones

• The use of cell phones, including texting or making calls, is strictly prohibited during the ride-along. This policy is in place to maintain focus on the activities at hand and to ensure the safety of all participants.

#### No Weapons

Participants are prohibited from carrying any weapons during the ride-along for the safety of everyone involved.

#### Be Observant

While engagement is encouraged, refrain from interfering with police operations; instead, observe and learn from a safe distance.

If you have time constraints and need to return to your vehicle by a specific time, please communicate this to the officer in advance. Thank you for choosing to participate in a ride-along with the Tuscaloosa Police Department. Your adherence to the outlined rules ensures a safe and enriching experience for everyone involved. As you accompany our officers on their duties, we hope you gain valuable insights into the challenges and rewards of serving the Tuscaloosa community.
