The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford City Hall of the City of Oxford, Alabama, on Tuesday, July 22, 2025, at approximately 6:28 o'clock p.m. Council President Pro Tempore Waits called the meeting to order.

Council President Pro Tempore Waits led the Pledge of Allegiance to the Flag.

APPROVAL OF MINUTES

Council President Pro Tempore Waits stated each member of the Council had previously received a copy of the minutes of the July 8, 2025 meeting. Council Member Henderson made a motion that the minutes be approved as presented. The motion was seconded by Council Member Hubbard.

Council President Pro Tempore Waits called for any comments or questions; there being none, on roll call the votes of the Council were as follows: ayes: Council Members Hubbard, Waits, and Henderson; nays: none; absent: Council Members Gardner and Spurlin. The motion carried.

Ordinance No. 2025- 36 – Ordinance rescinding Ordinance No. 2023-23 and designating a certain portion of Choccolocco Street as a one-way street (second reading)

Council Member Henderson made a motion to approve Ordinance Number 2025-36. The motion was seconded by Council Member Hubbard; and on call of the roll the following vote was recorded: ayes: none; nays: Council Members Hubbard, Waits and Henderson; absent: Council Members Gardner and Spurlin. The motion failed.

Council President Pro Tempore Waits stated the next item was the Consent Agenda.

Council Member Hubbard made a motion to approve Resolution No. 2025-62 and Resolution 2025-63. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Waits, and Henderson; nays: none; absent: Council Members Gardner and Spurlin. The motion carried and Resolution No. 2025-62 and Resolution No. 2025-63 were approved.

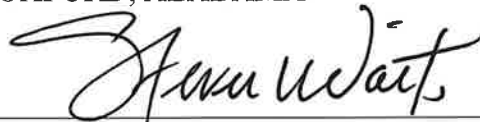

Zoning request from Buford and Teresa Crosson to rezone property located at 6037 Alabama Highway 202 from General Business District (GB) to Residential 1 District (R-1).

There being no further business to come before the Council, Council Member Henderson made a motion to adjourn. Council President Pro Tempore Waits declared the meeting adjourned at approximately 6:33 o’clock p.m.
