Chief Marcus Wood, Jacksonville Police Department and president of the Alabama Association of Chiefs of Police, presented a Certificate of Accreditation to Chief Bill Partridge and Assistant Chief Daniel Phipps, for the Oxford Police Department.

Chief Partridge stated that the professional services unit had worked tirelessly on this for the past three years.
