INVITATION TO BID

BID #06-25 Ol' Colony Fertilizers and Pesticides

Tuscaloosa County Park & Recreation (PARA) requests sealed bids to establish a contract for the purchase of select turf chemicals for the Division of Golf.

Sealed bids will be opened on <u>Tuesday, December 2, 2025, 10:00 a.m. CST</u> in the <u>Conference Room of the PARA Building, 614 Greensboro Avenue, Tuscaloosa, AL 35401</u> and may not be withdrawn for thirty (30) days after such date & time. CONDITION OF INVITATIONS TO BID

1. PREPARATION OF BIDS

Bids will be prepared in accordance with the following:

- (a) The enclosed Bidder's Response Form is to be used in submitting your bid.
- (b) Bidders shall make all investigations necessary to thoroughly inform themselves regarding plant and facilities for delivery of material and equipment as required by the bid conditions. No plea of ignorance by the bidder of conditions that exist or that may hereafter exist because of failure or omission on the part of the bidder to make the necessary examinations and investigations, or failure to fulfill in every detail the requirements of the contract documents, will be accepted as a basis for varying the requirements of PARA or the compensation to the vendor.
- (c) Bidders are advised that all PARA contracts are subject to all legal requirements provided for the Purchasing ordinance and/or State and Federal Statutes.
- (d) Bidder will not include federal taxes nor State of Alabama sales, excise, and use taxes in bid prices as PARA is exempt from payment of such taxes.

2. BIDDER/CONTRACTOR QUALIFICATIONS

To be eligible for a contract award, you must be qualified and able to provide the following:

- (a) Bidder must be an original manufacturer, or distributor and/or dealer/company authorized by manufacturer to sell their products.
- (b) Bidder must be in the business of providing turf fertilizers and chemicals for the past five years.

3. SPECIFICATIONS

Fertilizers and/or turf chemicals must conform to the specifications listed on the Bidder's Response Form.

4. SUBMISSION OF BIDS

Bids and changes thereto shall be enclosed in sealed envelopes addressed to Taylor Lopez, PARA, 614 Greensboro Avenue, Tuscaloosa, AL 35401. The name and address of the bidder, the date and hour of the bid opening and the bid title (Bid 06-25 Ol' Colony Fertilizers and Pesticides) shall be placed on the outside of the envelope. Bids may be mailed or delivered in person. It is the bidders' responsibility to verify bids have been received.

5. LATE BIDS OR MODIFICATIONS

(a) Bids and modifications received after the time set for the bid opening will not be considered.

6. AWARD OF CONTRACT

- (a) If two or more bids received are for the same total amount or unit price, quality and service being equal, the contract shall be awarded to a local bidder.
- (b) Award shall be made based on the lowest per each item total cost from a responsive, responsible bidder who meets specifications.
- (c) A written award of acceptance (Purchase Order) mailed or otherwise furnished to the successful bidder shall result in a binding contract.

8. DELIVERY

Prices quoted must be FOB Tuscaloosa with all transportation charges prepaid. No additional charges or surcharges shall be permitted.

9. CLAIMS

Successful bidder(s) will be responsible for making all claims against carriers for missing or damaged items.

10. LOCAL, STATE, AND FEDERAL COMPLIANCE REQUIREMENTS

Bidders shall comply with all local, state, and federal directives, orders, and laws as applicable to this bid and subsequent contract(s).

11. COLLUSION

The bidder, by affixing his signature to this proposal, agrees to the following: "Bidder certifies that his bid is made without previous understanding, agreement, or connection with any person, firm, or corporation making a bid for the same items and is in all respects fair, without outside control, collusion, fraud, or otherwise illegal action."
