The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford City Hall of the City of Oxford, Alabama, on Tuesday, October 14, 2025, at approximate 6:43 o'clock p.m. Council President Spurlin called the meeting to order.

Ron Allen, City Attorney, was present.

Alan Atkinson, City Clerk, was present.

Keith McCullough, Oxford First Baptist Church, prayed the Invocation.

Council President Spurlin led the Pledge of Allegiance to the Flag.

The motion carried and the Consent Agenda, Resolution Numbers 2025-89 through 2025-102, were approved.

Council Member Henderson stated that he had attended the ribbon cutting for the new Wellborn Cabinets facility in the Industrial Park West. He stated they were thankful for the facility being located here in Oxford. He stated the Amazon warehouse on McIntosh Road had opened recently, also.

Council President Spurlin wished Alan Atkinson, City Clerk, a happy birthday.

Jane Batey addressed the Council on behalf of the Oxford Community Chorus. She stated they 81 people enrolled as chorus members. She stated that 75 of those members will participate in their holiday concert on November 18<sup>th</sup> at the Performing Arts Center. She stated they were making plans for a patriotic concert for next summer.

Thomas Shelton, downtown business owner, addressed the Council concerning a downtown entertainment district and asked that the Council look at the plan for the district and to look at other cities with similar districts before jumping to a decision on a downtown entertainment district.

Grant Whittle addressed, downtown resident, addressed the Council concerning a downtown entertainment district and stated he was very excited about a possible arts and entertainment district in the downtown area. He stated that he and his wife often drive to Trussville to visit their entertainment district. He stated he trusted the Council to have an entertainment district that is family friendly.

Gwen Parrish, 505 Main Street, addressed the Council concerning a downtown entertainment district and stated she and her husband were both downtown business owners and residents. She stated they were raising their family here. She stated their family visit all the businesses downtown and stated she trusted that Oxford would develop an entertainment center the right way. She stated they supported the development of a downtown entertainment district.

Alyssa Baxley, 508 Main Street, downtown business owner, addressed the Council concerning a downtown entertainment district and stated an entertainment district would be an overlay of the current zoning in place. She stated the current businesses serving alcohol were all responsible parties and the overlay would allow for a mixed use area. She stated the overlay could be adjusted over time as necessary.

Anjuli Thompson, downtown business owner, addressed the Council concerning a downtown entertainment district and stated she was intrigued by the idea and wanted to learn more about what a downtown entertainment district would entail.

Adam Morris, downtown business owner, addressed the Council concerning a downtown entertainment district and stated he did not know a lot about the entertainment district and would like to learn more about it. He stated they feel safe in downtown Oxford. He stated they have concerns with the bar opening downtown. He stated the lack of an entertainment district is not necessarily stopping businesses from locating downtown. He stated there were nine locations downtown currently selling alcohol.

Council President Spurlin stated if an entertainment district opened in downtown the City would have certain guidelines and enforcement tools.

Council Member Hubbard stated that the proposed business for downtown that would be more than 50% sale of alcohol had not come before the City Council for approval yet.

Will Freeman, pastor, Grace Baptist Church, addressed the Council concerning a downtown entertainment district and stated the city has a lot of passion to support new businesses and make

everyone feel safe. He stated he was learning what would be contained within an entertainment district. He stated they needed to keep it respectful for the business owners, the churches and the families.

There being no further business to come before the Council, Council Member Henderson made a motion to adjourn. Council President Spurlin declared the meeting adjourned at approximately 7:23 o'clock p.m.
