The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford City Hall of the City of Oxford, Alabama, on Monday, November 3, 2025, at approximate 10:14 o'clock a.m. Council President Spurlin called the meeting to order.

Ron Allen, City Attorney, was present.

Alan Atkinson, City Clerk, was present.

Jerry Starling, Angel Grove Baptist Church, prayed the Invocation.

Briggs, Brooks and Braxon Haynie led the Pledge of Allegiance to the Flag.

## APPROVAL OF MINUTES

Council President Spurlin stated each member of the Council had previously received a copy of the minutes of the October 28, 2025 meeting. Council Member Henderson made a motion that the minutes be approved as presented. The motion was seconded by Council Member Hubbard.

Council President Spurlin called for any comments or questions; there being none, on roll call the votes of the Council were as follows: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

## **NEW BUSINESS**

Council President Chris Spurlin administered the Oath of Office to Mayor-Elect Alton Craft.

Judge Shannon Page stated that twenty years ago his wife and he had made the decision to raise their family in Oxford and he stated every day that decision is validated by the Mayor and Council of Oxford. He stated it speaks volumes that the Mayor and City Council were re-elected in an uncontested election this year and speaks to the job they were doing for the City.

The Honorable Shannon Page administered the Oath of Office to the newly elected Council Members: Phil Gardner, Charlotte Hubbard, Mike Henderson, Chris Spurlin and Steven Waits.

Council Member Waits nominated Council Member Spurlin to serve as Council President. The motion was seconded by Council Member Gardner. There were no other nominations; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

Council Member Henderson nominated Council Member Waits to serve as Council President Pro Tempore. The motion was seconded by Council Member Gardner. There were no other nominations; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

Council Member Waits made a motion to appoint Ron Allen as City Attorney. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

Council Member Henderson made a motion to appoint Council Member Hubbard as the Council Liaison to the Planning Commission. The motion was seconded by Council Member Gardner; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

Council Member Hubbard made a motion to appoint Council Member Gardner as the Council Liaison to the Parks and Recreation Department. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

Council Member Gardner made a motion for the unanimous consent of the Council for the immediate consideration of Ordinance Number 2025-49. The motion was seconded by Council Member Hubbard; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

Unanimous consent of the Council having been given for the immediate consideration of Ordinance Number 2025-49, Council Member Henderson made a motion to approve Ordinance Number 2025-49. The motion was seconded by Council Member Hubbard; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried and Ordinance Number 2025-49 was approved.

Ordinance No. 2025-50 – Ordinance affirming Chapter 2, Section 2-6 of the City Code, City Depositories

The motion was seconded by Council Member Hubbard; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried.

The motion carried and Ordinance Number 2025-51 was approved.

Council President Spurlin stated the next item on the agenda was the Consent Agenda.

## Consent Agenda:

Resolution No. 2025 – 104 – Resolution authorizing an appropriation and purchase of Rescue Airbag Systems for the Fire Department from North American Fire Equipment Inc. (NAFECO) in the total amount of \$40,221.00.

Resolution No. 2025- 105 – Resolution declaring certain equipment surplus and authorizing its donation to Martha's Hope.

Council Member Waits made a motion to approve the Consent Agenda, Resolution Numbers 2025-104 and 2025-105. The motion was seconded by Council Member Henderson; and on call of the roll the following vote was recorded: ayes: Council Members Hubbard, Gardner, Waits, Henderson and Spurlin; nays: none. The motion carried and the Consent Agenda, Resolution Numbers 2025-104 and 2025-105, were approved.

Council Member Henderson stated that it was unusual for the Mayor and Council to be re-elected without any opposition, and he hoped that meant the citizens were happy with the services the City provides and the with the decisions made by the Council. He stated it has been a great experience for him to serve the City and to serve with this Council.
