City of Northport	<p><b>SR-69 North at Union Chapel Road Intersection Improvements:</b>            Construction is complete. TCRIC and Northport have provided 20% of the total project costs, consistent with the pre-existing agreement between the City of Northport and ALDOT. Supplemental agreement in an estimated amount of \$320,000 has been approved for overrun due to increased site excavation prior to construction; City of Northport (TCRIC) portion will be 20% of that estimate. TCRIC funds expended to date: \$800,000. Project accepted for maintenance by City of Northport in June 2022. Outstanding issue to fully close out project is pending condemnation case resolution. City of Northport has an invoice pending for Construction Inspection. The final contractor estimate has been processed.</p>
ALDOT	<p><b>SR-69 South (additional lanes and access management):</b>            TCRIC contributed \$700,000 to ALDOT toward the \$1.5 million total project cost.</p>
ALDOT	<p><b>SR-69 South - Turn Lane Intersection improvements:</b> TCRIC has committed and distributed \$1.9 million. All turn lanes are now open to motorist and the project is complete. Final estimate to GFC is also required for project close-out.</p>
Tuscaloosa County	<p><b>SR-69 North at Martin Road (intersection Improvements):</b> Tuscaloosa County project thru ALDOT permit: TCRIC reimbursed the County roughly \$1,100,100 and ALDOT reimbursed the County roughly \$285,000 for the remaining costs pursuant to a pre-existing agreement.</p>
ALDOT	<p><b>US-82/McFarland at Bear Creek Cutoff Road (Intersection Improvements):</b>            TCRIC provided all funding via ALDOT cost sharing agreement. Project payments to date: \$3,723,534.12. Project is closed out within ALDOT's system.</p>
Tuscaloosa County	<p><b>Bear Creek Road/Bear Creek Cutoff Road Improvements:</b>            The project was completed for a total cost of \$849,252.48 and project reimbursement was paid to the County by the Commission in February 2019.</p>
City of Tuscaloosa (as ALDOT project)	<p><b>US-82/McFarland Blvd at Hargrove Road (intersection Improvements, access management. and signalization work):</b> TCRIC provided total project reimbursement funding for this project in the amount of \$3,808,237.98.</p>
City of Northport	<p><b>Mitt Lary Road Improvements:</b> TCRIC reimbursed the City of Northport a total of \$7,754,557 for this project, with the final monthly reimbursement payment made March 9, 2020.</p>
ALDOT	<p><b>US-82/McFarland: SR-69 to Rice Mine Road:</b> TCRIC contributed a total of \$459,505.34, providing the 20% match with MPO for UT relocation (for Cities of Northport and Tuscaloosa) ALDOT has sent both COT and CON final invoices to finance; neither have been paid out as of 9/24/2025 due to ALDOT end of year close-out.</p>
