

Commission Status and General Information

The Tuscaloosa County Road Improvement Commission, Inc. (TCRIC) was created by House Bill 600 (Transforming Tuscaloosa Infrastructure) in 2015. In 2022, the members of TCRIC reincorporated TCRIC under Sections 11-81-265 and 11-81-266 of the *Code of Alabama* (1975) [Sections 6 and 7 of Act 2021-408 of the Alabama Legislature]. TCRIC is governed by a board of seven voting members and one ex officio member (as detailed below). TCRIC oversees the prioritization and financing of public road and bridge construction and maintenance projects, financed by tax proceeds allocated for use by TCRIC in accordance with HB 600. Initial priority projects identified in HB 600 include,

- Reimbursement of funds for improvements to Mitt Lary Road,
- Improvements to State Route 69 South (“SR-69 South”)
- Improvements to State Route 69 North (“SR-69 North”)
- Improvements to Martin Luther King Boulevard/Jack Warner Parkway (“MLK/JWP”)
- Improvements to McFarland Boulevard / US Highway 82 (“US-82”)
- Improvements to McWright’s Ferry Road
- Improvements to Bear Creek Cutoff Road
