REQUEST FOR PROPOSALS

Housing Choice Voucher Program HQS/NSPIRE-V Inspection Services Contract
April 1, 2026 – March 31, 2028

The Housing Authority of the City of Waterbury (hereinafter referred to as the “Authority”, “WHA”, or the “Housing Authority”) herein requests proposals for inspection services including the following:

Housing Choice Voucher Program Annual Inspections
Housing Choice Voucher Program Initial Move-in Inspections
Housing Choice Voucher Program Special Inspections
Housing Choice Voucher Program Re-Inspections

Proposals are invited from inspection companies (hereinafter referred to as “inspector”, “proposer”, “inspection company” “respondent”, “vendor” or “offeror”) that will comply with all requirements of applicable statutes, regulations, policies, and organizational objectives of the WHA.

Bidders must have experience in the provision of relevant Housing Choice Voucher inspection services. The inspection company must have knowledge, demonstrated experience, and valid certifications to perform HUD HQS and NSPIRE-V inspections. Bidders must also have knowledge of and experience working with governmental entities and regulations, and Connecticut and Federal housing programs.

This Request for Proposals (RFP) contains specific submission requirements, general scope of service requirements, and terms, conditions, and other pertinent information necessary for submitting a proposal. This RFP has been made available to the public **on January 31, 2026**.

Questions should be directed in writing to Shannon LeGassey, Purchasing Coordinator, no later than **February 13, 2026, at 10:00 am**. Proposals must be submitted on or before **10:00 am on March 2, 2026**. Submittals received after the deadline will not be considered.

Proposals may not be withdrawn for a period of ninety (90) days from submission deadline date.

WHA Mission, Description, Logistics

The Housing Authority of the City of Waterbury:

- Established to provide safe, decent, sanitary, and affordable housing to low-income families without discrimination.
- WHA owns and operates a variation of public housing developments and programs consisting of 2,100 Federal Housing Choice Vouchers and 735 public housing units.
- It is governed by a 5-member Board of Commissioners. Four members are appointed by the Board of Directors, and a Resident Commissioner is selected pursuant to the procedures found at CGS 8-41.
- The Board of Commissioners employs an Executive Director who manages the day-to-day operations of the WHA programs and facilities.
- Has a staff of 6 non-union administrators, 18 white collar employees and 17 blue collar employees.

The Authority's fiscal year runs from July 1st through June 30th.

REQUEST FOR PROPOSALS FOR HOUSING CHOICE VOUCHER PROGRAM HQS INSPECTION SERVICES

The Housing Authority of the City of Waterbury is accepting proposals for Housing Choice Voucher Program HQS/NSPIRE-V inspection services required in the administration and management of the Housing Authority. The WHA is seeking inspection services that fall into four (4) categories. These four categories are:

1. Housing Choice Voucher Program Annual Inspection
2. Housing Choice Voucher Program Initial Move-in Inspection
3. Housing Choice Voucher Program Special Inspection
4. Housing Choice Voucher Program Re-Inspection

The WHA will select the best, a combination of cost and competency = value based on the evaluation criteria contained on page 9 of this document. The WHA recognizes that inspection companies bring a synergy to the provisions of services but in an era of sequestration and intentional underfunding of the WHA's core programs, cost containment and value in services has become a paramount concern.

The term of the contract will be two (2) years beginning on or about April 1, 2026, through March 31, 2028, with option an of three (3) 1-year extensions. This contract will not exceed five (5) years.

The WHA reserves the right to, at any time during the ensuing contract period, and without penalty to any inspection company retained as a result of this RFP, conduct additional competitive solicitations to retain additional inspection services when, in the opinion of the WHA, it is in the best interests of the WHA to do so. Accordingly, any inspection company retained as a result of this RFP shall have the right to also respond to any such additional solicitation process, if conducted.

All inspectors shall at all times guarantee access by the Authority, HUD, or any of their duly authorized representatives to any books, documents, papers, and records of the inspection records that are directly pertinent to the specific contract, for the purpose of audit, examination, excerpts, and transcriptions.

All inspectors selected through this RFP process shall be required to retain all pertinent records for a period of not less than three (3) years after final payment has been made and all pending matters closed.

Services are to comply with all HUD Housing Choice Voucher Program HQS and NSPIRE-V Inspection criteria.

This is a solicitation for competitive proposals in accordance with CFR (85.36 (d) (3)) allowing for technical quantity or other factors (in addition to price) for securing services. Award will be made to the Respondents whose proposals are most advantageous to the Waterbury Housing Authority with price and other factors considered.

In submitting a response to this Request for Proposals, the Respondent acknowledges that the WHA shall not compensate the Respondent for any submission or contract negotiation costs, including costs for preparation, appearances or interviews, and/or travel expenses. It is essential that the respondent selected has the necessary knowledge, skills, and experience to implement all aspects of the work. All work is to be performed with the highest degree of professional standards, in compliance with HUD and DOH regulations, WHA policies and procedures, criteria and requirements, and local and state laws.

SUBMISSION PROCESS AND REQUIREMENTS

SUBMISSION DEADLINE

Proposals must be received by the Housing Authority on or before **March 2, 2026, by 10:00 am.** Late submissions, emailed, and faxed proposals will not be considered.

DEADLINE FOR WRITTEN QUESTIONS

Written questions must be received by the WHA no later than **10:00 am on February 13, 2026**. Questions must be submitted to: shannon.legassey@waterburyha.org

In order to maintain a fair and impartial competitive process, the WHA will answer inquiries only in response to written questions received within the specific time frame. The WHA must avoid private communication with prospective respondents. Written questions will be the only opportunity for respondents to inquire as to form and content. Please respect this policy and do not attempt to query WHA personnel or members of its Board of Commissioners regarding this RFP. The only queries that will be acknowledged are those written questions submitted in the manner and within the time frame indicated above.

TIME OF PERFORMANCE

The services of this contract shall commence upon its execution and may be terminated by the WHA for its convenience at any point with ten (10) days' written notice.

QUALIFICATIONS

Bidders must have knowledge of, and experience with, HUD Housing Choice Voucher Program HQS and NSPIRE-V inspection criteria and possess a valid certification to perform said inspections issued by an industry recognized organization. Bidders should also possess working knowledge of YARDI Inspection IQ software or the ability to acquire such knowledge. All inspectors must have experience inspecting dwelling units utilizing the most recent HQS inspection criteria and shall be conducted in accordance with HUD standards in compliance with 42 U.S.C. 143f.

During the term of this Contract, and effective February 1, 2027, the U.S. Department of Housing and Urban Development (HUD) will transition from the Housing Quality Standards (HQS) inspection protocol. All rental units assisted with Housing Choice Voucher funding shall thereafter be inspected in accordance with the National Standards for the Physical Inspection of Real Estate for Vouchers (NSPIRE-V). Proposers must possess current NSPIRE-V certification issued by an industry-recognized organization, including but not limited to NAHRO or Nan McKay.

NON-DISCRIMINATION

The Respondent must not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin. The Respondent shall take affirmative action to ensure that applicants are employed, and employees are treated during employment, without regard to race, color, religion, sex, age, or national origin. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment, or recruitment advertising, layoff or termination, rates of pay or other means of compensation, and selection for training, including apprenticeship.

CONFLICTS OF INTEREST

The respondent will be required to certify that to the best of his/her knowledge and belief and, except as otherwise disclosed, s/he does not have any organizational conflict of interest. Conflict of interest is defined as a situation in which the nature of work under this contract and the respondent's organizational, financial, contractual, or other interests are such that:

1. Award of the contract may result in an unfair competitive advantage; or
2. The respondent's objective in performing the contracted work may be impaired. In the event the respondent has an organizational conflict of interest as defined herein, the respondent shall disclose such conflict of interest fully in the proposal submission.
3. The respondent agrees that, after the award, s/he discovers an organizational conflict of interest with respect to this contract; s/he shall make an immediate and full disclosure in writing to the WHA's Executive Director. The disclosure shall include a description of the action that the respondent has taken or intends to take to eliminate or neutralize the conflict. The WHA may, however, terminate the contract if it is in the WHA's best interest and no other acceptable solution is possible.
4. In the event the respondent was aware of an organizational conflict of interest before the award of the contract and intentionally failed to disclose the conflict to the Executive Director, the WHA may terminate the contract.
5. No member or delegate to the U.S. Congress or the WHA Board of Commissioners shall be allowed to share in any part of this contract or to derive any benefit to arise there from. This provision shall be construed to extend to this contract if made with a corporation for its general benefit.
6. No member, officer, or employee of the WHA, no member of the Board of Commissioners, and no other public official of such locality or localities who exercises any function or responsibilities with respect to the project shall, during his/her tenure, or for one (1) year thereafter, have any interest, direct or indirect, in this contract or the proceeds thereof.
7. The WHA reserves sole and total discretion in determining the proper treatment of any conflict of interest disclosed under this provision.

NON-ASSIGNMENT

The Respondent shall not assign or transfer any interest in this Contract except that claims for monies due or to become due from the WHA under the Contract may be assigned to a bank, trust company, or other financial institution. If the Respondent is a partnership, this Contract shall inure to the benefit of the surviving or remaining member(s) of such partnership.

PROPOSAL SUBMISSION and DEADLINE

Proposals must be received no later than **10:00 am on March 2, 2026**, at the Housing Authority of the City of Waterbury, 2 Lakewood Road, Waterbury, CT 06704.

As stated on page 5, proposals and proposed fees must be submitted in a sealed envelope or box marked “Proposal for RFP S-HQSINS04012026 HCV HQS/NSPIRE-V Inspection Services”. Submittals received after the deadline will not be considered.

No proposal shall be withdrawn for a period of ninety (90) days subsequent to opening without the consent of the WHA.

Proposals shall include the following:

1. Timetable

- **Introductory works** - Please indicate when you would be able to start the engagement and begin to familiarize yourself with the WHA.
- **Transition/Start-up** – Describe the transition process and the time necessary to complete.

2. Background, Experience and Approach

- An executive summary of the proposal, including a statement of the respondent’s understanding of the services provided.
- A brief narrative describing the respondent’s location; background and history, including years of Housing Choice Voucher Program HQS inspection experience, number of staff; work experience associated with Housing Choice Voucher Program HQS inspection; inspection experience related the Scope of Service and the rating factors; and the respondent’s ability to provide Housing Choice Voucher Program HQS inspection services to the WHA.
- A list of at least three (3) current clients for whom services of a similar nature has been performed. For each client, please include a brief description of its organization and complexity and provide a point of contact and telephone number.
- Certified statement that the respondent is in good standing.
- A non-collusive affidavit (page 17 of this document).
- Current HQS/NSPIRE-V certification issued by an industry-recognized organization for all inspectors that will work on this contract.
- Provide proof of insurance to conduct HQS inspections in Connecticut dwellings.
- Proposed fees for inspections to be performed.

3. Staff Capability

- Provide information clearly demonstrating your capability to perform Housing Choice Voucher Program annual HQS/NSPIRE-V inspections and Housing Choice Voucher Program special inspections and other services as stated in the Scope of Services for each area of service for the Respondent is seeking selection. This information should include resumes of the team who would be assigned to the WHA and any other information relevant to your qualifications to perform these services for the WHA.
- Steps taken at your inspection company to ensure continuity in the assignment of key staff from year-to-year.
- Commitments you will make regarding the inspectors’ accessibility to the WHA.
- A description of your inspection company’s approach to providing Housing Choice Voucher Program HQS/NSPIRE-V inspection services to the WHA.

4. Hours and Professional Fees

- Your description of fees should include whatever schedules are necessary to adequately support and/or explain the proposed pricing. The basis for the fees should be stated (i.e., number of staff, hourly rates, etc.). Please complete page 16 of this document “Fee Schedule Form” and include a description of expected billing arrangements.

5. Summation

- Please conclude with a statement about how your inspection company differs from other inspection companies offering similar services. Address how the WHA will benefit from the services provided by your firm.

EVALUATION PROCESS AND SELECTION CRITERIA

Proposals will be evaluated by a WHA selection committee. The committee will present its recommendations to the WHA Board of Commissioners, who will make the final selection.

Proposals will be evaluated using the Evaluation Criteria outlined below. After the initial scoring of proposals, those deemed by the selection committee to be within the competitive range will become the finalists and may be asked to appear for an interview to clarify issues and, if necessary, following the interview, submit their best and final offers.

Proposals for each area of service will be compared to others in the same category when it comes to a specific area of service proposed. A Respondent must receive at least 50 points under the General Category to be evaluated under the Specific Category.

The Authority reserves the right to make an award without further discussion of the proposals submitted or to not conduct an interview process. Therefore, the proposals should be clear and complete regarding the above criteria.

COSTS INCURRED IN PREPARING AND SUBMITTING PROPOSALS

The respondent shall be solely responsible for all costs incurred in preparing and submitting a response to this RFP. All material and documents submitted by the respondent will become the property of the WHA and will not be returned. Inspection companies selected for further negotiations, as well as the respondent ultimately selected to enter into a contractual agreement with the WHA, will be solely responsible for all costs incurred during negotiations.

CONTRACT/AWARD

The contract for Housing Choice Voucher Program HQS inspection services as requested in this RFP will be subject to the approval of the WHA's Board of Commissioners at their March 18, 2026, Board Meeting.

The RFP will result in a fixed fee contract, the terms of which will be negotiated between the WHA and the selected respondent. The contract shall commence on the date specified therein and shall terminate upon completion of all services required pursuant to the contract unless terminated as provided therein. The term of the contract shall not exceed five (5) years.

LIMITATION

This Request for Proposals does not commit the WHA to award a contract or to pay any cost incurred in the preparation and submittal of a proposal to this request. The Authority reserves the right to accept or reject any or all proposals, to negotiate with all qualified sources, or to cancel in part or in its entirety the Request for Proposals, and to waive any informality regarding the proposals received whenever such acceptance, rejection, negotiation, cancellation, or waiver is in the best interest of the WHA.

ADDENDA

Any Addenda issued to provide additional information, responses to questions, or other changes in the RFP, must be included with the submission as a signed copy acknowledging the Addenda. Any response will be assumed to have been prepared with full knowledge of the content of any addenda issued by the WHA.

GENERAL INFORMATION

We currently have 2,100 vouchers requiring annual inspections. Inspection numbers will vary from month to month regarding move-in, special, and re-inspections. The Housing Choice Voucher Program Client Services Department has seven (7) certification specialists with whom you would communicate and collaborate with working towards our common goal. The Client Services Department is managed by Dana Serra, the Director of Leased Housing.

EXHIBITS

SCOPE OF SERVICES

The scope of services for which WHA is soliciting proposals from qualified, licensed, and bonded entities to provide comprehensive inspection services to the Waterbury Housing Authority. The examples of services shall include, but are not limited to the following:

Inspection Standards:

1. The successful proposer shall meet all the applicable State and local housing quality standards, codes, and the requirements set forth in 24 CFR (the “Property Standards”).
2. Possess or be able to acquire the electronic inspection data collection systems required: YARDI Inspection IQ software.
3. All inspectors must have knowledge of, and experience with, HUD Housing Choice Voucher Program HQS and NSPIRE-V inspection criteria and possess a valid certification to perform said inspections issued by an industry recognized organization.

Services:

4. Services include physical inspection of all units as required by the HA, including inspections of unit interiors, building systems, common areas, building exteriors and sites at all properties. HQS inspections shall be conducted in accordance with HUD standards in compliance with 42 U.S.C. 1437f.
5. Inspection services are to include: Initial/Move-in upon receipt of a Request for Tenancy Approval, Annual inspections yearly at move-in date anniversary, special inspections are done at the request of tenant or landlord, and re-inspections are done after a unit has initially failed & it has been reported by the landlord that all required repairs have been made.
6. Copies of inspection report shall be submitted to the HA no more than three (3) business days after completion of each inspection, so the HA may take corrective measures in a timely fashion.
7. The successful proposer shall be responsible for all associated inspection paperwork, including but not limited to notification to tenants and landlords of a scheduled inspection, rescheduling re-inspections and no-show, and notification to landlords via certified mail of failed items.
8. Upon request of the HA, provide photographs at no charge from the inspection for various reasons such as tenant-related damage.

Notifications:

9. The successful proposer shall notify the residents of inspection dates no less than 48 hours prior to inspection.
10. Though the HA and the apparent successful proposer will, through negotiation, mutually agree on satisfactory completion schedule, the HA expects that the successful proposer will have the required experience and resources to complete the inspection in a timely manner.
11. The scheduling of the Annual inspections will coincide with the residents’ annual recertification date. The inspector will work with the caseworker to schedule annual inspections at the appropriate dates; Annual inspection shall be scheduled at least 90 days prior to the annual recertification date.
12. The scheduling of New Move-in inspections shall be done no more than 10 days after receipt of the Request for Tenancy Approval paperwork. The scheduling of Special inspections shall be done no more than 5 days after the request is received.

Customer Service:

13. The vendor is expected to uphold a certain level of customer service to both the tenant and landlord clientele. To maintain this level, the vendor shall guarantee the following services.
14. The vendor shall have at a minimum of three (3) days per week, set business hours where clients may call and speak with an individual regarding any inspection-related business.
15. The vendor shall guarantee that any person placing a call to their business outside of the set business hours of operation will have the ability to leave a message.

16. During the days with open business hours, the vendor shall retrieve all messages from the night before on the following morning. During days with no open business hours, the vendor shall retrieve all messages at the close of business on that day.

17. All messages, return phone calls, and/or emails shall be returned or responded to within 24 hours. All pending issues or questions shall be addressed within 24 hours.

Reports:

18. Reports that the HA expects to be delivered to the HA by the successful proposer include, but may not be limited to, the following, on a per inspection basis.

19. Completing HUD form 52580-A in the format that meets the HUD requirements for inspection of all units. To meet these requirements, each inspectable item must have one of three entries, and an appropriate defect level identified for each level. This report is the Waterbury Housing Authority Executive Director's document to certify to HUD that the annual inspection requirements have been met.

20. Detailed List of Deficiencies Report that only lists the defects observed on/in the property and what actions are required to pass those items.

21. Exigent Health and Fire Safety Report, which is generated at the end of each workday to alert the HA to any safety conditions noted that day. Per HUD standards, the Landlord has 24 hours to correct the ensuing emergency failed items.

22. Abatement Notification List: Upon failing to correct a required Emergency 24 Hour repair item within the allotted timeframe, the landlord will be sent a notification of abatement. A daily list of newly abated properties and the reason for abatement shall be sent to the HA to allow the HA to properly withhold HAPs on a timely basis.

23. Release of Abatement Notification List: This list will be sent daily and will notify the case workers of which previously abated units have passed inspection and can be released from abatement.

24. Additional information within reports: Notations of housekeeping issues; Notations of Unauthorized Individuals residing in the unit. 1. Preparation of Offers

(a) Offerors are expected to examine the statement of work, the proposed contract terms and conditions, and all instructions. Failure to do so will be at the offeror's risk.

(b) Each offeror shall furnish the information required by the solicitation. The offeror shall sign the offer and print or type its name on the cover sheet and each continuation sheet on which it makes an entry. Erasures or other changes must be initialed by the person signing the offer. Offers signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the HA.

(c) Offers for services other than those specified will not be considered.

2. Submission of Offers

(a) Offers and modifications thereof shall be submitted in sealed envelopes or packages (1) addressed to the office specified in the solicitation, and (2) showing the time specified for receipt, the solicitation number, and the name and address of the offeror.

(b) Telegraphic offers will not be considered unless authorized by the solicitation; however, offers may be modified by written or telegraphic notice.

(c) Facsimile offers, modifications or withdrawals will not be considered unless authorized by the solicitation.

3. Amendments to Solicitations

(a) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

(b) Offerors shall acknowledge receipt of any amendments to this solicitation by

- (1) signing and returning the amendment;
- (2) identifying the amendment number and date in the space provided for this purpose on the form for submitting an offer,
- (3) letter or telegram, or
- (4) facsimile, if facsimile offers are authorized in the solicitation. The HA/HUD must receive the acknowledgment by the time specified for receipt of offers.

4. Explanation to Prospective Offerors

Any prospective offeror desiring an explanation or interpretation of the solicitation, statement of work, etc., must request it in writing soon enough to allow a reply to reach all prospective offerors before the submission of their offers. Oral explanations or instructions given before the award of the contract will not be binding. Any information given to a prospective offeror concerning a solicitation will be furnished promptly to all other prospective offerors as an amendment of the solicitation, if that information is necessary in submitting offers or if the lack of it would be prejudicial to any other prospective offerors.

5. Responsibility of Prospective Contractor

(a) The HA shall award a contract only to a responsible prospective contractor who is able to perform successfully under the terms and conditions of the proposed contract. To be determined responsible, a prospective contractor must -

- (1) Have adequate financial resources to perform the contract, or the ability to obtain them;

- (2) Have a satisfactory performance record;
- (3) Have a satisfactory record of integrity and business ethics;
- (4) Have a satisfactory record of compliance with public policy (e.g., Equal Employment Opportunity); and
- (5) Not have been suspended, debarred, or otherwise determined to be ineligible for award of contracts by the Department of Housing and Urban Development or any other agency of the U.S. Government. Current lists of ineligible contractors are available for inspection at the HA/HUD.

(b) Before an offer is considered for award, the offeror may be requested by the HA to submit a statement or other documentation regarding any of the foregoing requirements. Failure by the offeror to provide such additional information may render the offeror ineligible for award.

6. Late Submissions, Modifications, and Withdrawal of Offers

(a) Any offer received at the place designated in the solicitation after the exact time specified for receipt will not be considered unless it is received before award is made and it -

- (1) Was sent by registered or certified mail not later than the fifth calendar day before the date specified for receipt of offers (e.g., an offer submitted in response to a solicitation requiring receipt of offers by the 20th of the month must have been mailed by the 15th);
- (2) Was sent by mail, or if authorized by the solicitation, was sent by telegram or via facsimile, and it is determined by the HA/ HUD that the late receipt was due solely to mishandling by the HA/ HUD after receipt at the HA;
- (3) Was sent by U.S. Postal Service Express Mail Next Day Service - Post Office to Addressee, not later than 5:00 p.m. at the place of mailing two working days prior to the date specified for receipt of proposals. The term "working days" excludes weekends and U.S. Federal holidays; or
- (4) Is the only offer received.

(b) Any modification of an offer, except a modification resulting from the HA's request for "best and final" offer (if this solicitation is a request for proposals), is subject to the same conditions as in subparagraphs (a)(1), (2), and (3) of this provision.

(c) A modification resulting from the HA's request for "best and final" offer received after the time and date specified in the request will not be considered unless received before award and the late receipt is due solely to mishandling by the HA after receipt at the HA.

(d) The only acceptable evidence to establish the date of mailing of a late offer, modification, or withdrawal sent either by registered or certified mail is the U.S. or Canadian Postal Service postmark both on the envelope or wrapper and on the original receipt from the U.S. or Canadian Postal Service. Both postmarks must show a legible date or the offer, modification, or withdrawal shall be processed as if mailed late. "Postmark" means a printed, stamped, or otherwise placed impression (exclusive of a postage meter machine impression) that is readily identifiable without further action as having been supplied and affixed by employees of the U.S. or Canadian Postal Service on the date of mailing. Therefore, offerors should request the postal clerk to place a hand cancellation bull's-eye postmark on both the receipt and the envelope or wrapper.

"Postmark" has the same meaning as defined in paragraph (c) of this provision, excluding postmarks of the Canadian Postal Service. Therefore, offerors should request the postal clerk to place a legible hand cancellation bull's eye postmark on both the receipt and the envelope or wrapper.

(g) Notwithstanding paragraph (a) of this provision, a late modification of an otherwise successful offer that makes its terms more favorable to the HA will be considered at any time it is received and may be accepted.

(h) If this solicitation is a request for proposals, proposals may be withdrawn by written notice, or if authorized by this solicitation, by telegram (including mailgram) or facsimile machine transmission received at any time before award. Proposals may be withdrawn in person by a offeror or its authorized representative if the identity of the person requesting withdrawal is established and the person signs a receipt for the offer before award. If this solicitation is an invitation for bids, bids may be withdrawn at any time prior to bid opening.

7. Contract Award

(a) The HA will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the HA, cost or price and other factors, specified elsewhere in this solicitation, considered.

(b) The HA may

- (1) reject any or all offers if such action is in the HA's interest,
- (2) accept other than the lowest offer,
- (3) waive informalities and minor irregularities in offers received, and (4) award more than one contract for all or part of the requirements stated.

(c) If this solicitation is a request for proposals, the HA may award a contract on the basis of initial offers received, without discussions. Therefore, each initial offer should contain the offeror's best terms from a cost or price and technical standpoint.

(d) A written award or acceptance of offer mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer shall result in a binding contract without further action by either party. If this solicitation is a request for proposals, before the offer's specified expiration time, the HA may accept an offer, whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award. Negotiations conducted after receipt of an offer do not constitute a rejection or counteroffer by the HA.

- (c) "Contractor" means the person or other entity entering into the contract with the Authority to perform all of the work required under the contract.
- (d) "Day" means calendar days, unless otherwise stated.
- (e) "HUD" means the Secretary of Housing and Urban Development, his delegates, successors, and assigns, and the officers and employees of the United States Department of Housing and Urban Development acting for and on behalf of the Secretary.

2. Changes

- (a) The HA may at any time, by written order, and without notice to the sureties, if any, make changes within the general scope of this contract in the services to be performed or supplies to be delivered.
- (b) If any such change causes an increase or decrease in the hourly rate, the not-to-exceed amount of the contract, or the time required for performance of any part of the work under this contract, whether or not changed by the order, or otherwise affects the conditions of this contract, the HA shall make an equitable adjustment in the not-to-exceed amount, the hourly rate, the delivery schedule, or other affected terms, and shall modify the contract accordingly.
- (c) The Contractor must assert its right to an equitable adjustment under this clause within 30 days from the date of receipt of the written order. However, if the HA decides that the facts justify it, the HA may receive and act upon a

proposal submitted before final payment of the contract.

- (d) Failure to agree to any adjustment shall be a dispute under clause Disputes, herein. However, nothing in this clause shall excuse the Contractor from proceeding with the contract as changed.
 - (e) No services for which an additional cost or fee will be charged by the Contractor shall be furnished without the prior written consent of the HA.
- #### 3. Termination for Convenience and Default
- (a) The HA may terminate this contract in whole, or from time to time in part, for the HA's convenience or the failure of the Contractor to fulfill the contract obligations (default). The HA shall terminate by delivering to the Contractor a written Notice of Termination specifying the nature, extent, and effective date of the termination. Upon receipt of the notice, the Contractor shall: (i) immediately discontinue all services affected (unless the notice directs otherwise); and (ii) deliver to the HA all information, reports, papers, and other materials accumulated or generated in performing this contract, whether completed or in process.
 - (b) If the termination is for the convenience of the HA, the HA shall be liable only for payment for services rendered before the effective date of the termination.
 - (c) If the termination is due to the failure of the Contractor to fulfill its obligations under the contract (default), the HA may (i) require the Contractor to deliver to it, in the manner and to the extent directed by the HA, any work as described in subparagraph (a)(ii) above, and compensation be determined in accordance with the Changes clause, paragraph 2, above; (ii) take over the work and prosecute the same to completion by contract or otherwise, and the Contractor shall be liable for any additional cost incurred by the HA; (iii) withhold any payments to the Contractor, for the purpose of off-set or partial payment, as the case may be, of amounts owed to the HA by the Contractor.

 - (ii) litigation or settlement of claims arising from the performance of this contract; or,
 - (iii) costs and expenses of this contract to which the HA, HUD, or Comptroller General or any of their duly authorized representatives has taken exception shall continue until disposition of such appeals, litigation, claims, or exceptions.

5. Rights in Data (Ownership and Proprietary Interest)

The HA shall have exclusive ownership of, all proprietary interest in, and the right to full and exclusive possession of all information, materials and documents discovered or produced by Contractor pursuant to the terms of this Contract, including but not limited to reports, memoranda or letters concerning the research and reporting tasks of this Contract.

6. Energy Efficiency

The contractor shall comply with all mandatory standards and policies relating to energy efficiency which are contained in the energy conservation plan issued in compliance with the Energy Policy and Conservation Act (Pub.L. 94-163) for the State in which the work under this contract is performed.

7. Disputes

- (a) All disputes arising under or relating to this contract, except for disputes arising under clauses contained in Section 111, Labor Standards Provisions, including any claims for damages for the alleged breach there of which are not disposed of by agreement, shall be resolved under this clause.
- (b) All claims by the Contractor shall be made in writing and submitted to the HA. A claim by the HA against the Contractor shall be subject to a written decision by the HA.
- (c) The HA shall, with reasonable promptness, but in no event in no more than 60 days, render a decision concerning any claim hereunder. Unless the Contractor, within 30 days after receipt of the HA's decision, shall notify the HA in writing that it takes exception to such decision, the decision shall be final and conclusive.
- (d) Provided the Contractor has (i) given the notice within the time stated in paragraph (c) above, and (ii) excepted its claim relating to such decision from the final release, and (iii) brought suit against the HA not later than one year after receipt of final payment, or if final payment has not been made, not later than one year after the Contractor has had a reasonable time to respond to a written request by the HA that it submit a final voucher and release, whichever is earlier, then the HA's decision shall not be final or conclusive, but the dispute shall be determined on the merits by a court of competent jurisdiction.
- (e) The Contractor shall proceed diligently with performance of this contract, pending final resolution of any request for relief, claim, appeal, or action arising under the contract, and comply with any decision of the HA.

8. Contract Termination; Debarment

A breach of these Contract clauses may be grounds for termination of the Contract and for debarment or denial of participation in HUD programs as a Contractor and a subcontractor as provided in 24 CFR Part 24.

9. Assignment of Contract

The Contractor shall not assign or transfer any interest in this contract, except that claims for monies due or to become due from the HA under the contract may be assigned to a bank, trust company, or other financial institution. If the Contractor is a partnership, this contract shall inure to the benefit of the surviving or remaining member(s) of such partnership approved by the HA.

10. Certificate and Release

Prior to final payment under this contract, or prior to settlement upon termination of this contract, and as a condition precedent thereto, the Contractor shall execute and deliver to the HA a certificate and release, in a form acceptable to the HA, of all claims against the HA by the Contractor under and by virtue of this contract, other than such claims, if any, as may be specifically excepted by the Contractor in stated amounts set forth therein.

11. Organizational Conflicts of Interest

- (a) The Contractor warrants that to the best of its knowledge and belief and except as otherwise disclosed, it does not have any organizational conflict of interest which is defined as a situation in which the nature of work under this contract and a contractor's organizational, financial, contractual or other interests are such that:
 - (i) Award of the contract may result in an unfair competitive advantage; or
 - (j) The Contractor's objectivity in performing the contract work may be impaired.
- (b) The Contractor agrees that if after award it discovers an organizational conflict of interest with respect to this contract or any task/delivery order under the contract, he or she shall make an immediate and full disclosure in writing to the Contracting Officer which shall include a description of the action which the Contractor has taken or intends to take to eliminate or neutralize the conflict. The HA may, however, terminate the contract or task/delivery order for the convenience of the HA if it would be in the best interest of the HA.
- (c) In the event the Contractor was aware of an organizational conflict of interest before the award of this contract and intentionally did not disclose the conflict to the Contracting Officer, the HA may terminate the contract for default.
- (d) The terms of this clause shall be included in all subcontracts and consulting agreements wherein the work to be performed is similar to the service provided by the prime Contractor. The Contractor shall include in such subcontracts and consulting agreements any necessary provisions to eliminate or neutralize conflicts of interest.

12. Inspection and Acceptance

- (a) The HA has the right to review, require correction, if necessary, and accept the work products produced by the Contractor. Such review(s) shall be carried out within 30 days so as to not impede the work of the Contractor. Any

product of work shall be deemed accepted as submitted if the HA does not issue written comments and/or required corrections within 30 days from the date of receipt of such product from the Contractor.

- (b) The Contractor shall make any required corrections promptly at no additional charge and return a revised copy of the product to the HA within 7 days of notification or a later date if extended by the HA.
- (c) Failure by the Contractor to proceed with reasonable promptness to make necessary corrections shall be a default. If the Contractor's submission of corrected work remains unacceptable, the HA may terminate this contract (or the task order involved) or reduce the contract price or cost to reflect the reduced value of services received.

13. Interest of Members of Congress

No member of or delegate to the Congress of the United States of America or Resident Commissioner shall be admitted to any share or part of this contract or to any benefit to arise there from, but this provision shall not be construed to extend to this contract if made with a corporation for its general benefit.

14. Interest of Members, Officers, or Employees and Former Members, Officers, or Employees

No member, officer, or employee of the HA, no member of the governing body of the locality in which the project is situated, no member of the governing body in which the HA was activated, and no other public official of such locality or localities who exercises any functions or responsibilities with respect to the project, shall, during his or her tenure, or for one year thereafter, have any interest, direct or indirect, in this contract or the proceeds thereof.

15. Limitation on Payments to Influence Certain Federal Transactions

(a) Definitions. As used in this clause:

"Agency", as defined in 5 U.S.C. 552(f), includes Federal executive departments and agencies as well as independent regulatory commissions and Government corporations, as defined in 31 U.S.C. 9101(1).

"Covered Federal Action" means any of the following Federal actions:

- (i) The awarding of any Federal contract;
- (ii) The making of any Federal grant;
- (iii) The making of any Federal loan;
- (iv) The entering into of any cooperative agreement; and
- (v) The extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

Covered Federal action does not include receiving from an agency a commitment providing for the United States to insure or guarantee a loan.

"Indian tribe" and "tribal organization" have the meaning provided in section 4 of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450B). Alaskan Natives are included under the definitions of Indian tribes in that Act.

"Influencing or attempting to influence" means making, with the intent to influence, any communication to or appearance before an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any covered Federal action.

"Local government" means a unit of government in a State and, if chartered, established, or otherwise recognized by a State for the performance of a governmental duty, including a local public authority, a special district, an intrastate district, a council of governments, a sponsor group representative organization, and any other instrumentality of a local government.

"Officer or employee of an agency" includes the following individuals who are employed by an agency:

- (i) An individual who is appointed to a position in the Government under title 5, U.S.C., including a position under a temporary appointment;
- (ii) A member of the uniformed services as defined in section 202, title 18, U.S.C.;
- (iii) A special Government employee as defined in section 202, title 18, U.S.C.; and,
- (iv) An individual who is a member of a Federal advisory committee, as defined by the Federal Advisory Committee Act, title 5, appendix 2.

"Person" means an individual, corporation, company, association, authority, firm, partnership, society, State, and local government, regardless of whether such entity is operated for profit or not for profit. This term excludes an Indian tribe, tribal organization, or other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Recipient" includes all contractors, subcontractors at any tier, and subgrantees at any tier of the recipient of funds received in connection with a Federal contract, grant, loan, or cooperative agreement. The term excludes an Indian tribe, tribal organization, or any other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Regularly employed means, with respect to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, an officer or employee who is employed by such person for at least 130 working days within one year immediately preceding the date of the submission that initiates agency consideration of such person for receipt of such contract, grant, loan, or cooperative agreement. An officer or employee who is employed by such person for less than 130 working days within one year immediately preceding the date of submission that initiates agency consideration of such person shall be considered to be regularly employed as soon as he or she is employed by such person for 130 working days.

"State" means a State of the United States, the District of Columbia, the Commonwealth of Puerto Rico, a territory or possession of the United States, an agency or instrumentality of a State, and a multi-State, regional, or interstate entity having governmental duties and powers.

(b) Prohibition.

- (i) Section 1352 of title 31, U.S.C. provides in part that no appropriated funds may be expended by the recipient of a Federal contract, grant, loan, or cooperative agreement to pay any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any of the following covered Federal actions: the awarding of any Federal contract, the making of any Federal grant, the making of any Federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

(v) The prohibition does not apply as follows:

(1) Agency and legislative liaison by Own Employees.

(a) The prohibition on the use of appropriated funds, in paragraph (i) of this section, does not apply in the case of a payment of reasonable compensation made to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, if the payment is for agency and legislative activities not directly related to a covered Federal action.

(b) For purposes of paragraph (b)(i)(1)(a) of this clause, providing any information specifically requested by an agency or Congress is permitted at any time.

(c) The following agency and legislative liaison activities are permitted at any time only where they are not related to a specific solicitation for any covered Federal action:

(1) Discussing with an agency (including individual demonstrations) the qualities and characteristics of the person's products or services, conditions or terms of sale, and service capabilities; and,

(2) Technical discussions and other activities regarding the application or adaptation of the person's products or services for an agency's use.

(d) The following agency and legislative liaison activities are permitted where they are prior to formal solicitation of any covered Federal action:

(1) Providing any information not specifically requested but necessary for an agency to make an informed decision about initiation of a covered Federal action;

(2) Technical discussions regarding the preparation of an unsolicited proposal prior to its official submission; and

(3) Capability presentations by persons seeking awards from an agency pursuant to the provisions of the Small Business Act, as amended by Public Law 95-507 and other subsequent amendments.

(e) Only those activities expressly authorized by subdivision (b)(i)(1)(a) of this clause are permitted under this clause.

(2) Professional and technical services.

(a) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply in the case of-

(i) A payment of reasonable compensation made to an officer or employee of a person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action, if payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action.

(ii) Any reasonable payment to a person, other than an officer or employee of a

person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action if the payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action. Persons other than officers or employees of a person requesting or receiving a covered Federal action include consultants and trade associations.

(b) For purposes of subdivision (b)(ii)(2)(a) of clause, "professional and technical services" shall be limited to advice and analysis directly applying any professional or technical discipline.

(c) Requirements imposed by or pursuant to law as a condition for receiving a covered Federal award include those required by law or regulation, or reasonably expected to be required by law or regulation, and any other requirements in the actual award documents.

(d) Only those services expressly authorized by subdivisions (b)(ii)(2)(a)(i) and (ii) of this section are permitted under this clause.

The [contractor/seller] will take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, sex, sexual orientation, gender identity, disability, or national origin. Such action shall include, but not be limited to the following: Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeship. The [contractor/seller] agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the contracting officer setting forth the provisions of this nondiscrimination clause.

(g) In the event of the [contractor/seller]'s non-compliance with the nondiscrimination clauses of this contract or with any of such rules, regulations, or orders, this contract may be canceled, terminated or suspended in whole or in part and the [contractor/seller] may be declared ineligible for further Government contracts in accordance with procedures authorized in Executive Order 11246 of September 24, 1965, and such other sanctions may be imposed and remedies invoked as provided in Executive Order 11246 of September 24, 1965, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.

(h) The [contractor/seller] will include the provisions of paragraphs (a) through (h) in every subcontract or purchase order unless exempted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each sub[contractor/seller] or vendor. The [contractor/seller] will take such action with respect to any subcontract or purchase order as may be directed by the Secretary of Labor as a means of enforcing such provisions including sanctions for noncompliance: Provided, however, that in the event the [contractor/seller] becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the [contractor/seller] may request the United States to enter into such litigation to protect the interests of the United States.

17. Equal Opportunity for Workers with Disabilities

1. The [contractor/seller] will not discriminate against any employee or applicant for employment because of physical or mental disability in regard to any position for which the employee or applicant for employment is qualified. The [contractor/seller] agrees to take affirmative action to employ and advance in employment individuals with disabilities, and to treat qualified individuals without discrimination on the basis of their physical or mental disability in all employment practices, including the following:

21. Liens

- (d) The contractor agrees to include this section 3 clause in every subcontract subject to compliance with regulations in 24 CFR Part 75, and agrees to take appropriate action, as provided in an applicable provision of the subcontract or in this section 3 clause, upon a finding that the subcontractor is in violation of the regulations in 24 CFR Part 75. The contractor will not subcontract with any subcontractor where the contractor has notice or knowledge that the subcontractor has been found in violation of the regulations in 24 CFR Part 75.

3. Records

- (a) The Contractor and each subcontractor shall make and maintain for three (3) years from the completion of the work records containing the following for each laborer and mechanic:
 - (i) Name, address and Social Security Number;
 - (ii) Correct work classification or classifications;
 - (iii) Hourly rate or rates of monetary wages paid;
 - (iv) Rate or rates of any fringe benefits provided;

Section II – Labor Standard Provisions for all Maintenance Contracts greater than \$2,000

1. Minimum Wages

- (a) All maintenance laborers and mechanics employed under this Contract in the operation of the project(s) shall be paid unconditionally and not less often than semi-monthly, and without subsequent deduction (except as otherwise provided by law or regulations), the full amount of wages due at time of payment computed at rates not less than those contained in the wage determination of the Secretary of Housing and Urban Development which is attached hereto and made a part hereof. Such laborers and mechanics shall be paid the appropriate wage rate on the wage determination for the classification of work actually performed, without regard to skill. Laborers or mechanics performing work in more than one classification may be compensated at the rate specified for each classification for the time actually worked therein; provided, that the employer's payroll records accurately set forth the time spent in each classification in which work is performed. The wage determination, including any additional classifications and wage rates approved by HUD under subparagraph 1(b), shall be posted at all times by the Contractor and its subcontractors at the site of the work in a prominent and accessible place where it can be easily seen by the workers.
- (b) (i) Any class of laborers or mechanics which is not listed in the wage determination and which is to be employed under the Contract shall be classified in conformance with the wage determination. HUD shall approve an additional classification and wage rate only when the following criteria have been met:
 - (1) The work to be performed by the classification required is not performed by a classification in the wage determination;
 - (2) The classification is utilized in the area by the industry; and
 - (3) The proposed wage rate bears a reasonable relationship to the wage rates contained in the wage determination.
- (ii) The wage rate determined pursuant to this paragraph shall be paid to all workers performing work

Apprenticeship Training, Employer and Labor Services (OATELS), or with a state apprenticeship agency recognized by OATELS, or if a person is employed in his/her first 90 days of probationary employment as an apprentice in such an apprenticeship program, who is not individually registered in the program, but who has been certified by OATELS or a state apprenticeship agency (where appropriate) to be eligible for probationary employment as an apprentice; A

- (i) trainee program which has received prior approval, evidenced by formal certification by the U.S. Department of Labor, ETA; or
- (ii) A training/trainee program that has received prior approval by HUD.

- (b) Each apprentice or trainee must be paid at not less than the rate specified in the registered or approved program for the apprentice's/trainee's level of progress, expressed as a percentage of the journeyman hourly rate specified in the applicable wage determination. Apprentices and trainees shall be paid fringe benefits in accordance with the provisions of the registered or approved program. If the program does not specify fringe benefits, apprentices/trainees must be paid the full amount of fringe benefits listed on the wage determination for the applicable classification.
- (c) The allowable ratio of apprentices or trainees to journeyman on the job site in any craft classification shall not be greater than the ratio permitted to the employer as to the entire work force under the approved program.
- (d) Any worker employed at an apprentice or trainee wage rate who is not registered in an approved program, and any apprentice or trainee performing work on the job site in excess of the ratio permitted under the approved program, shall be paid not less than the applicable wage rate on the wage determination for the classification of work actually performed.
- (e) In the event OATELS, a state apprenticeship agency recognized by OATELS or ETA, or HUD, withdraws approval of an apprenticeship or trainee program, the employer will no longer be permitted to utilize apprentices/trainees at less than the applicable predetermined rate for the work performed until an acceptable program is approved.

5. Disputes concerning labor standards

- (a) Disputes arising out of the labor standards provisions contained in Section II of this form HUD-5370-C, other than those in Paragraph 6, shall be subject to the following procedures. Disputes within the meaning of this paragraph include disputes between the Contractor (or any of its subcontractors) and the HA, or HUD, or the employees or their representatives, concerning payment of prevailing wage rates or proper classification. The procedures in this section may be initiated upon HUD's own motion, upon referral of the HA, or upon request of the Contractor or subcontractor(s).
 - (i) A Contractor and/or subcontractor or other interested party desiring reconsideration of findings of violation by the HA or HUD relating to the payment of straight-time prevailing wages or classification of work shall request such reconsideration by letter postmarked within 30 calendar days of the date of notice of findings issued by the HA or HUD. The request shall set

forth those findings that are in dispute and the reasons, including any affirmative defenses, with respect to the violations. The request shall be directed to the appropriate HA or HUD official in accordance with instructions contained in the notice of findings or, if the notice does not specify to whom a request should be made, to the Regional Labor Relations Officer (HUD). The HA or HUD official shall, within 60 days (unless otherwise indicated in the notice of findings) after receipt of a timely request for reconsideration, issue a written decision on the findings of violation. The written decision on reconsideration shall contain instructions that any appeal of the decision shall be addressed to the Regional Labor Relations Officer by letter postmarked within 30 calendar days after the date of the decision. In the event that the Regional Labor Relations Officer was the deciding official on reconsideration, the appeal shall be directed to the Director, Office of Labor Relations (HUD). Any appeal must set forth the aspects of the decision that are in dispute and the reasons, including any affirmative defenses, with respect to the violations. The Regional Labor Relations Officer shall, within 60 days (unless otherwise indicated in the decision on reconsideration) after receipt of a timely appeal, issue a written decision on the findings. A decision of the Regional Labor Relations Officer may be appealed to the Director, Office of Labor Relations, by letter postmarked within 30 days of the Regional Labor Relations Officer's decision. Any appeal to the Director must set forth the aspects of the prior decision(s) that are in dispute and the reasons. The decision of the Director, Office of Labor Relations, shall be final.

- (b) Disputes arising out of the labor standards provisions of paragraph 6 shall not be subject to paragraph 5(a) of this form HUD-5370C. Such disputes shall be resolved in accordance with the procedures of the U.S. Department of Labor set forth in 29 CFR Parts 5, 6 and 7. Disputes within the meaning of this paragraph 5(b) include disputes between the Contractor (or any of its subcontractors) and the HA, HUD, the U.S. Department of Labor, or the employees or their representatives.

6. Contract Work Hours and Safety Standards Act

The provisions of this paragraph 6 are applicable only where the amount of the prime contract exceeds \$100,000. As used in this paragraph, the terms "laborers" and "mechanics" includes watchmen and guards.

- (a) **Overtime requirements.** No Contractor or subcontractor contracting for any part of the Contract work which may require or involve the employment of laborers or mechanics shall require or permit any such laborer or mechanic in any workweek in which he or she is employed on such work to work in excess of 40 hours in such workweek unless such laborer or mechanic receives compensation at a rate not less than one and one-half times the basic rate of pay for all hours worked in excess of 40 hours in such workweek.
- (b) **Violation; liability for unpaid wages; liquidated damages.** In the event of any violation of the provisions set forth in paragraph 6(a), the Contractor and any

subcontractor responsible therefor shall be liable for the unpaid wages. Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the provisions set forth in paragraph (a) of this clause, in the sum of \$10 for each calendar day on which such individual was required or permitted to work in excess of the standard workweek of 40 hours without payment of the overtime wages required by provisions set forth in paragraph (a) of this clause.

- (c) **Withholding for unpaid wages and liquidated damages.** HUD or its designee shall upon its own action or upon written request of an authorized representative of the U.S. Department of Labor withhold or cause to be withheld, from any moneys payable on account of work performed by the Contractor or subcontractor under any such Contract or any federal contract with the same prime Contractor, or any other federally-assisted contract subject to the Contract Work Hours and Safety Standards Act, which is held by the same prime Contractor such sums as may be determined to be necessary to satisfy any liabilities of such Contractor or subcontractor for unpaid wages and liquidated damages as provided in the provisions set forth in paragraph (b) of this clause.

7. Subcontracts

The Contractor or subcontractor shall insert in any subcontracts all the provisions contained in this Section II and also a clause requiring the subcontractors to include these provisions in any lower tier subcontracts. The prime Contractor shall be responsible for the compliance by any subcontractor or lower tier subcontractor with all the provisions contained in these clauses.

8. Non-Federal Prevailing Wage Rates

Any prevailing wage rate (including basic hourly rate and any fringe benefits), determined under state law to be prevailing, with respect to any employee in any trade or position employed under the Contract, is inapplicable to the contract and shall not be enforced against the Contractor or any subcontractor, with respect to employees engaged under the contract whenever such non-Federal prevailing wage rate, exclusive of any fringe benefits, exceeds the applicable wage rate determined by the Secretary of HUD to be prevailing in the locality with respect to such trade or position.
