The City Council of the City of Oxford, Alabama, met in Regular Session in the Oxford Performing Arts Center of the City of Oxford, Alabama, on Tuesday, September 8, 2020, at approximately 6:30 o'clock p.m. Council President Spurlin called the meeting to order.

Ron Allen, City Attorney, was present.

Alan Atkinson, City Clerk, was present.

Minister Dell Kimberly, Betta View Hills Church of Christ, prayed the Invocation.

Council President Spurlin led the Pledge of Allegiance to the Flag.

Council President Spurlin stated each member of the Council had previously received a copy of the minutes of the August 27, 2020 meeting and the September 1, 2020 meeting. Council Member Henderson made a motion that the minutes be approved as presented. The motion was seconded by Council Member Gardner.

Council President Spurlin called for any comments or questions; there being none, on roll call the votes of the Council were as follows: ayes: Council Members Gardner, Henderson and Spurlin; nays: none; abstentions: Council Member Hubbard; absent: Council Member Waits. The motion carried.

NEW BUSINESS

The motion carried and Ordinance Number 2020-21 was approved.

Council Member Hubbard stated there would be a ribbon cutting for the new "Welcome Signs" on September 30th at 9:00 a.m. at the Bynum Fire Station.

Mayor Craft stated that an Auburn University study had shown that people exiting the interstate in our area did not know they were in Oxford but thought they were in Anniston. He stated that Chief Sparks, Fire Department, was home from the hospital.

Council President Spurlin stated they needed to set public hearings for September 22, 2020, to consider condemnations at 643 Buckelew Bridge Road, 74 Gwin Street, 312 W. Oak Street, 329 Alice Street, 414 W. Oak Street, and 415 Alice Street.

There being no further business to come before the Council, Council Member Henderson made a motion to adjourn. Council President Spurlin declared the meeting adjourned at approximately 6:46 o'clock p.m.
