APPLICATION

Type of Assistance

The Alabama REALTORS® Foundation is accepting applications through January 31, 2021 from REALTORS® and homeowners who suffered losses related to Hurricanes Sally and Zeta. The relief fund is designed to help offset REALTOR® and homeowner losses not covered by a homeowner policy, other insurance or disaster relief programs.

Relief assistance is available in the maximum amounts per application per household as outlined below:

- Homeowner - \$2,500
- Renter - \$1,500

Please note these funds do not include assistance for damage to second homes, businesses, landscaping, outbuildings, trees, fencing or automobiles. Daily business expenses are ineligible for reimbursement under this program.

Eligibility

Recipients must be full time residents of Alabama. Applicants must be a REALTOR® or referred by a REALTOR®. All applications must be verified by a REALTOR®. See REALTOR® verification section for details.

Confidentiality

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance provided. It will not be shared with other parties for any other purpose.

Disbursement of Funds

The Alabama REALTORS® Foundation Trustees will evaluate the applications based on need and award grants in February.
