



# Alabama REALTOR® Foundation Disaster Relief Fund Application

**Time Period:** Alabama Storms March 25, 2021  
**Damage Area:** Bibb, Calhoun, Cherokee, Chilton, Clay, Coosa, Cullman, Greene, Hale, Jefferson, Perry, Pickens, Randolph, Shelby, St. Clair and Tuscaloosa  
**Application Deadline:** April 30, 2021

## APPLICATION

### *Type of Assistance*

Assistance is available to qualified applicants towards financial loss related to applicant’s primary residence that was damaged due to the storms on March 25, 2021. The relief fund is designed to help offset losses not covered by an insurance policy or government disaster relief programs. Funds may be used for insurance deductibles, repairs, and other out of pocket expenses related to damages incurred to primary residence but not covered by insurance.

Relief assistance is available in the maximum amounts per application per household as outlined below:

- Homeowner - \$2,500
- Renter - \$1,500

Deadline for application submission is April 30, 2021. Please note these funds do not include assistance for damage to second homes, landscaping, outbuildings, trees, fencing or automobiles. Daily business expenses are ineligible for reimbursement under this program.

### *Eligibility*

Recipients must be fulltime residents of Alabama. Applicants must be a REALTOR® or referred by a REALTOR®. All applications must be verified by a REALTOR®. See REALTOR® verification section for details.

### *Confidentiality*

All information provided on this form will remain confidential and will be available only to those who need to confirm eligibility for assistance and to those who process the assistance provided. It will not be shared with other parties for any other purpose.

### *Disbursement of Funds*

An independent committee will evaluate the applications based on need and award grants at the close of the application period. All grants are contingent upon the availability of funds.

## ATTACHMENT CHECKLIST

### *Required for All Applicants*

1. Photo identification to show proof of residency (i.e., driver’s license or other governmental documentation showing residency)
2. Copy of mortgage statement, mortgage payment coupon or rent statement or lease agreement establishing residency.
3. Photos of damage.

### *One of the Following is Required to Show Extent of Damage to your Primary Residence:*

1. Insurance Estimate
2. Copies of Written Claims, Settlement Proceeds or Claim Status Reports
3. Copies of Repair Estimates from Licensed Contractors
