**1. Chief Larry Horton (C Hall) (MFD)** – Consider approval to purchase new Recliners, Kitchen Table and Chairs. Vendor: Firehouse Furniture. Cost: \$10,500.00, Capital Budget Request. Motion was made by Council Member Nick Rutledge to approve. Motion was seconded by Council Member Lynn Taylor and all present voted AYE: Motion was carried by unanimous vote.

**2. Chief Reece Smith (S Humber) (MPD)** – Consider approval to have windows tinted 2<sup>nd</sup> floor Board Room glass front on Police Department. Vendor: Cool Vu, Cost: not to exceed \$1,680.00. Budgeted item 01-513-2501. Motion was made by Council Member Nick Rutledge to approve. Motion was seconded by Council Member Linda Crowe and all present voted AYE: Motion was carried by unanimous vote.

**3. Mike Staggs (Park and Rec)** – Consider approval to purchase a portable diesel tank for park (58) gallons. Vendor: Vevor, Cost: \$547.00, Budgeted: Park and Grounds 01-551-1000. Motion was made by Council Member Nick Rutledge to approve. Motion was seconded by Council Member Ellis Key and all present voted AYE: Motion was carried by unanimous vote.

**4. Mike Staggs (Park and Rec)** – Consider approval to cover cost of “Thunder in the Park” on July 12, 2025: Vendor: Pyro Shows of Alabama, Ashville Inflatables, Sound and Entertainment, Banners, T-Shirts and Misc. Cost: \$19,500.00, Budgeted item Festival Expense 01-560-1000. Motion was made by Council Member Nick Rutledge to approve. Motion was seconded by Council Member Matt Morris and all present voted AYE: Motion was carried by unanimous vote.

**5. Lee Drummonds (Public Works)** – Consider approval to purchase (1) Husqvarna Chainsaw with a 36 inch Cutting Bar and (1) Redmax Blower. Vendor: Tri-County Turf Equipment, LLC, Cost: \$1,900.00. Budgeted item, Capital 01-515-9900. Motion was made by Council Member Ellis Key to approve. **6. Mike Staggs (Park and Rec)** – Consider approval to rent an Aerator (1 week) to aerate athletic fields at the park. Vendor: Jerry Pate Rentals. Cost: \$2,200.00 Budgeted: Park and Grounds, 01-551-1000. Motion was made by Council Member Nick Rutledge to approve. Motion was seconded by Council Member Lynn Taylor and all present voted AYE: Motion was carried by unanimous vote.

**7. Mayor Lee** – Consider approval to add to Pickle Ball Project. Add to Bid with Milam and Co. additional 185' of 5' wide and 25' of 8' wide sidewalk along the end of the basketball court to the tennis court / kiddie Park restrooms. Cost \$12,874.75. Funded from Sec 6 Capital Account. Motion was made by Council Member Matt Morris to approve. Motion was seconded by Council Member Nick Rutledge and all present voted AYE: Motion was carried by unanimous vote.

**8. Mayor Lee** – Consider approval of a Public Works Project to repair, resurface, new post, backboards and goals at the basketball at the Moody City Park. Vendors: Central Alabama Asphalt (Asphalt, Materials and Repair Bid), Public Works and Others. Cost not to exceed \$35,000.00. Funded from Sec 6 Capital Account. Motion was made by Council Member Lynn Taylor to approve. Motion was seconded by Council Member Matt Morris and all present voted AYE: Motion was carried by unanimous vote.
