3. Chief Reece Smith (MPD) – Consider approval to purchase a mobile speaker unit for the base station radio. Vendor: Red Beard Solutions. Cost: \$715.00. Budgeted item Radio Equipment 01-513-2503. This will give the developer time to resolve deficiencies in drainage, sidewalk, roads, and other items brought by the homeowners and the city council in phase 1, phase 2 and in the requested areas.
