- **1. Mayor Lee** Proclamation presented in recognition of the 20th Anniversary of Pastor William Vincent Curtis of First Missionary Baptist Church.
- **2. Sara Roberts (Library)** Consider approval to name Kathrine Lambert to the Library Board of Trustees, replacing a Board member whose term has expired.
